Title: Car parking fees Christmas and New Year

Summary

1. This report relates to proposals to support the vitality of the district's centres during the coming Christmas and New Year festive season.

Recommendations

- 2. That car parking fees for the following car parks not be enforced for the period Monday 24 December to Tuesday 1 January inclusive:
 - Angel Lane and Chequers Lane, Great Dunmow
 - Lower Street, Stansted Mountfitchet
 - Swan Meadow, Saffron Walden

Financial Implications

3. The potential loss of revenue based on usage of these car parks in the same period 2011/12 is £2,000. This can be met from the positive variation of car parks income compared to the budget figure.

Situation

- 6. The Economic Development Strategy recently approved by Cabinet includes the objective that the district's four centres should offer a viable and exciting offer as an alternative to out of centre shopping, the internet and competing town centres, and seeks to achieve year on year increases in footfall.
- 7. The council has been working with town and parish councils, Saffron Walden Initiative, chambers of trade and businesses to prepare town centre management plans but proposals have already emerged for initiatives to support retailing during the Christmas season. This is a crucial period for business incomes when margins are generated over costs. Requests have been received from Great Dunmow Town Council and Saffron Walden Town Council for parking charges to be waived in the run up to Christmas on Saturdays/ dates of promotional activities, and two days in the pre Christmas week respectively, and from the Saffron Walden Initiative for free parking after 3:00pm.
- 8. There is little capacity in car parks in the peak period before Christmas. Parking fees are a measure to manage demand at these times, and ensure that there is a turnover of users, and that opportunity exists for people to park and support trade with local businesses. The ticket machines are configured to support the current parking tariff arrangements. However, the council is in a position to offer concessions on Christmas Eve and between Christmas and New Year when there is space available and our local centres have the potential to limit the leakage of trade away out of the district to larger centres by an enhanced local offer.

9. The cost/ benefit and feasibility of free parking after 3:00pm more generally could be considered in setting fees and charges for the FY2013/14.
