YOU HAVE NOT FULLY ADDRESSED THE ISSUES OF TRANSPORT, DUTY

GREAT CHESTERFORD PARISH COUNCIL ASKS WHAT HAS

CHANGED SINCE OCTOBER LAST YEAR WHEN THE PREVIOUS PLAN WAS

PAUSED. THE PARISH COUNCIL OBTAINED, THROUGH A FREEDOM OF

INFORMATION REQUEST, A COPY OF THE MEDIA PACK UDC ISSUED AND

THEN WITHDREW IN OCTOBER. THIS MEETING SHOULD NOTE THAT

UDC INITIALLY REFUSED TO DISCLOSE THIS ITEM AND WE HAD TO

FOLLOW THE APPEALS PROCESSTO GET HOLD OF IT.

THAT MEDIA PACK MADE NO MENTION OF A SITE IN GREAT
CHESTERFORD. SO CAN THIS MEETING CONFIRM WHAT CHANGED?
HAS UDC SPENT THE LAST 7 OR 8 MONTHS FINDING
A WAY TO INCLUDE GREAT CHESTERFORD AS A SETTLEMENT IN
ORDER TO MAKE IT MORE POLITICALLY PALATABLE TO ITS MEMBERS?
IF NOT, WHAT ARE ALL THE PRECISE REASONS FOR THE ORIGINAL
NON-INCLUSION OF GREAT CHESTERFORD AND ITS INCLUSION NOW?
