Summary		

1. This report sets out the agreed criteria and recommendations for allocation of funds to Community/Voluntary groups and Town/Parish Councils made by the Jubilee Fund Working Group.

Recommendations

- 2. Members are requested to:
- 2.1 endorse the recommendations made by the Working Group, attached at Appendix 1.
- 2.2 to approve that once the further information requested for some of the Town/Parish Councils has been received then the Working Group could determine whether or not to award funding, and
- 2.3 to consider whether or not the remaining unallocated portion of the Town/Parish Councils' fund should be transferred to the Community/Voluntary groups' fund (as that was oversubscribed) to enable more of those applications to be considered.

Financial Implications

3. The Jubilee Fund is a one-off grant scheme for the financial year 2012/13 and is to be funded from the New Homes Bonus allocation.

Situation

- The Council agreed to allocate a one off sum of £250,000 to the Community/Voluntary Groups and £250,000 to Town and Parish Councils from its New Homes Bonus allocation for 2012/13.
- 7. It was agreed that the application forms would be assessed by a working group comprising the Leader of the Council, Portfolio Holder for Finance and Administration, Portfolio Holder for Community Partnerships and Engagement, and a representative from each of the opposition parties along with an independent member from the Local Strategic Partnership, with officer support.
- 8. The Council received 35 applications from Town/Parish Councils totalling £233,427.07 and 119 applications from Voluntary/Community Groups with a combined total requested £721,589.59.
- 9. The Working Group met on 2 August and agreed the principles to be used for allocation of the funding. It was recognised some difficult decisions would

have to be made as the fund was three times oversubscribed. Agreed principles were as follows:

- a. application meets the criteria as set out in the form
- b. projects which are considered inappropriate or not in the spirit of the Jubilee Fund will not be supported.
- c. only one bid will be considered from each organisation;
- d. where alternative means of funding could be applied for applications will not be considered
- e. if an applicant requires 100% funding to undertake and complete the project the application will not be considered;
- f. majority of applications to receive 50% of their request, if they can continue with the project by down scaling or applying for alternative funding
- 10. The Working Group also considered the Town/Parish Councils' applications on an individual basis. It was decided that just because the fund was undersubscribed applications should not automatically receive funding as it was deemed to be important that the projects complied with the spirit of the Jubilee Fund as well as satisfying the agreed criteria. Therefore, further information was requested on some of the projects (which has not been received at the time of writing this report). All applications were considered against the following criteria:
 - a. it meets the criteria as set out on the application form;
 - b. some projects were considered inappropriate or not in the spirit of the Jubilee Fund.
 - c. where alternative means of funding could be applied for applications may not be considered
