Summary

1. This reports seeks a decision from Members regarding the distribution of funding to be allocated to Great Dunmow and Stansted Skatepark.

Situation

- 5. Two reports were submitted to the Community Committee on 14 September 2006 requesting funding for skateparks. Stansted Parish Council requested a further contribution of £20,000 towards the next phase of the development and Great Dunmow Parish Council requested a contribution of £30,000.
- 6. The Community Committee on 14 September 2006 approved a set of criteria against which funding requests could be scored. The criteria was fairly comprehensive in that it sought demonstration that projects complied with the Council's corporate plan and that the applicants were sufficiently organised to seek funding from a range of organisations as well as providing a management or business plan for the activity. The criteria was then applied to the Great Dunmow and Stansted Skatepark applications and both of these scored highly enough to achieve an award of full funding subject to Committee approval.
- 7. The Community Committee, after considering each project against the set of scored criteria recommended to the Operations Committee that both Councils should be awarded the amounts as requested.
- 8. Although the Operations Committee could consider the recommendations in the light of the Council's overall Capital Programme, under Financial Regulations it had to refer the matter to Full Council for the final decision on what, if anything, to add to the Programme. In doing so, the Operations Committee asked for further details to be made available to the Full Council, particularly in relation to funding being obtained from other sources by the applicants.
- 9. At the Council meeting held on the 17 October 2006 it was resolved that the sum of £40,000 in total from the capital programme be allocated to the community Committee and that Committee be authorised to determine the level of grant to the Dunmow and Stansted Skateboard Park Schemes.
