#### **Situation**

- 4. An informal meeting has been held between councillors who expressed an interest in contributing towards establishing an action plan for developments in the run up to the Olympics. However, the Community Committee is requested to formally establish a Task Group comprising Members of this Committee. The purpose of the Task Group will be to consider and advise the Community Committee on matters relating to developments to maximise benefits from the Olympics for Uttlesford (see Appendix 1).
- 5. As a result of the Essex-wide work being undertaken it is likely that decisions may need to be taken within a fairly short timescale and the process may not comply with the committee cycle in Uttlesford. Therefore, it may be necessary for officers to take action should timescales dictate that decisions are taken outside of the Committee cycle.
  - a. For example, a key piece of work at the moment is for districts to decide if they wish to submit an application to be considered to host an Olympic or Paralympic preparation camp. The submission has to be made by 31 January 2006. Discussions are being undertaken with Leisure Connection Ltd, other partners and districts i.e. Brentwood and Harlow to establish how Uttlesford might best participate in the Olympics, following the outcome a decision will be required regarding making a submission.
  - b. However, Members recognise that the main involvement within this district is likely to be through encouraging support for young people's involvement, delivery of a cultural programme and, in particular, tourism development. Officers are, therefore, pursuing these areas and two key possibilities are currently being investigated:
    - development of a Cultural Festival in the district in 2008 to support the Beijing Olympics and allied to the Saffron Walden Museum's participation in a cultural touring exhibition around the County containing Chinese costumes, and
    - ii. the possibility of expanding existing school links with a Chinese twin town.
