# Minutes of a Meeting of the Tenant Forum Held on Monday 14 May 2007 at Saffron Walden Council Offices

**Officers in attendance:** Helen Joy (Tenant Participation Officers); Liz Petrie (Housing Management Manager); Roz Millership (Division Head Housing).

## 1. APOLOGIES

Daphne gave a short tribute to Jill Bolvig – Hansen. Daphne expressed her sadness in Jill's sudden death and talked about Jill's life and the work Jill did for the tenants of UDC and how she was a champion for all tenants and officers.

Roz Millership was introduced as the new head of division for housing. Roz also paid a short tribute to Jill explaining how Jill had been at the start of the Councils Tenant Forum and how hard Jill had worked to get the tenants voices heard.

Roz explained about her new post and how she felt it was now time to move the service forward, she explained that the government have lots on new tenant lead policy changes in the pipe line and the government bodies will expect the Council to demonstrate that tenant participation is being down.

Roz explained that funding had been suspended but the Council are trying to find other sources George suggested that if the contractors were not going to call that they let people know.

Sam Sproul asked Roz why it took from the 12 February until the 7 March for his credit card payment to go onto his rent account. Helen Joy agreed to look into this

Colin Gilbey asked what the external painting programme for leasehold properties is. Roz said 5 Years. Colin also asked if the properties were surveyed because the flats at Birdbush Ave need the pointing and concrete down frames looking at. Roz agreed to have this looked at but explained that they would be a re-charge to leaseholders in the block.

Paul reported a tenant at 11 Berners End Banrston to have a leak around her chimney, repairs officers have visited the property but only when its been sunny and the now it has started raining the leak is back. Helen agreed to speak to Russell Goodey the repairs Manger.

Colin Gilbey asked for an amendment on page 3 of the previous minutes he explained the problem with the front door was not on his own door.

#### 3. MATTERS ARISING
