### Summary

1 This report provides the Committee with details of applications for funding under the three year Contributions Fund Scheme and requests from the Thaxted Festival and the Dunmow Maltings Preservation Trust.

### Recommendations

- 2 It recommends:
  - (a) that Members determine whether grant allocations for the Contributions Fund Scheme should be considered for the setting of draft budgets for 2008/09;
  - (b) that members determine whether funding the Thaxted Festival £3,500 per annum for the next three years should be included in the setting of the draft budgets
  - (c) that Members determine whether to fund the Dunmow Maltings £1.000 following their request for an annual grant contribution for three years towards its day-to-day running costs should be considered in the setting of the draft budgets.

## Situation

- 5 The Contributions Fund Scheme, previously named the Voluntary Organisation Support Grant (VOSG), is so named in recognition of the valuable contribution that the Council makes to fund the recipient organisations to provide services, which the Council might otherwise have to provide.
- 6 The following organisations have received an annual inflationary uplift contribution from the Contributions Fund Scheme for the past three years -Uttlesford Citizen's Advice Bureau (UCAB), Bishop's Stortford CAB (BSCAB), the Council for Voluntary Services, Uttlesford (CVSU) and the Uttlesford Volunteer Bureau (UVB). Smaller grants/subscriptions amounting to £7,680 are awarded to Rural Community Council Essex, Eastern Orchestral, Eastern Arts and Eastern Essex Sport – a further report will be brought to the next committee concerning these allocations.
- 7 In addition, Uttlesford Community Travel (UCT) has a three-year funding arrangement with the Council which is split between on-going revenue costs and a capital contribution towards the costs of replacement vehicles. The Environment & Transport Committee originally allocated the capital and revenue contribution but subsequently agreed for funds of £30,000 to be ringfenced and transferred to the Community and Leisure Committee to allocate towards Community Transport revenue provision in the District and £12,000 per annum capital funding towards the provision of new community minibuses – these funds are allocated from the Community Project Grant and these monies are ring-fenced for this purpose.

- 8 The appended table below illustrates the funds that have been allocated to each organisation (providing details of the grant awarded for this financial year) and the funding requests that are being sought for the next three years. The total amount in the existing budget is £129,100 (revenue funding) plus £12,000 (capital finding ring fenced for UCT).
- 9 All five organisations are seeking an increase to their previous contributions and this amounts to more than would have been allocated if inflation had been built into the previous contributions. The requests received amount to £177,920 (revenue funding) and £15,000 (capital funding) which, without growth, exceed the budget allocation by approximately £48,820 for revenue funding and £3,000 for capital funding. Each has applied for a further contribution for the next three-year period that this Scheme is to run – 2008 – 2011. All organisations have a Service Level Agreement (SLA) with the Council as they receive funding of over £5k.
- 10 In making their application, the organisations indicated that they would welcome the opportunity to work more closely in partnership with the Council through a robust SLA that has been in operation for the past three years.. They have confirmed how useful and helpful it has been to have the security of a three-year funding arrangement. They have indicated, however, their concern that if future funding arrangements do not reflect the inflationary increase that has accrued over the three years, or that will accrue over the coming three years, they will find it difficult to manage their finances.
- 11 Organisations in receipt of a contribution under this Scheme will be required to enter into a further SLA with the Council for the next three-year period. The SLA will define the arrangements between the Council and the organisation and the purpose for which the grant is made. In addition, the outcomes that the Council will expect to see as a result of funding the organisation will be included in the Agreement. Officers will monitor the SLA during the year.
- 12 On an annual basis, the Funding and Strategic Partnership's Officer will meet with representatives of each these organisations to assess that the service arrangements that are being provided meet the agreed standard, review these, if necessary, provide an annual report to this Committee, and approve the payment for the next year.

# 13 The Options

The Committee has a range of options that it may wish to consider:

- a. Cease funding the Contribution Fund Scheme
- b. Provide funding solely for the next financial year with a built in review for future funding in September 2008
- c. Provide funding for the next three years at the same level as is currently being received
- d. Consider increasing the levels of funding as requested by the organisations

e. Provide funding at the current levels received but with an inflationary uplift over the next three years.

# **Other Requests Received**

## 14 Thaxted Music Festival –

The Festival is an annual event that is considered to attract audiences from Essex and beyond. Thaxted is not the ideal venue for a festival as it is a relatively small community, is unable to attract many local sponsors and relies on the local church as its main venue for hosting concerts. The Festival has been in receipt of a grant from the Council for the past three years - £2,500 (05/06), £3,000(06/07) and ££3,080 (07/08).

- 15 The Festival has only remained financially viable due to the fact that it is staffed by volunteers and has received financial support from the Council, Essex County Council, the Eastern Orchestral Board and the Eastern Arts Council.
- 16 It is recognised that the Festival is an economic asset to the local community and beyond as it both promotes culture and tourism and has associated economic spin-offs for the local community.
- 17 The Council could elect to provide no grant at all but it is considered that this could have a detrimental effect on the long term viability of the Festival and the associated economic spin-offs. In addition, the Council has been recognised in the past as being one of the major sponsors and its contribution has been well advertised in all the promotional literature connected with the Festival.
- 18 It is generally considered that the Festival provides an economic and cultural focus of international re-known for the district. Comments from Festival attendees suggest that there is a consensus that the Festival should continue and encourage new artists into the musical arena.

## 19 Great Dunmow Maltings Preservation Trust

The Council entered into an agreement with the Trust following the restoration of the Malting and allocated £1,000 towards the day-to-day running costs of the building - this grant has been match-funded by the Great Dunmow Town Council. The agreement came to en end in the financial year 2006/07.

- 20 The Malting is a building of high architectural interest that is open to the public and, is as such, an important local focal point for tourists visiting the District. The building dates from around 1580 and is considered completely unique as being the only surviving floor malting in the Country in such good condition.
- 21 The Trust charges admission fees and raises funds from room hire to local community organisations. It is run on an entirely voluntary basis apart from one part-time cleaner and it also acts as a Visitor Information Point for tourists during its opening hours.

22 The funding requested would be allocated towards the restricted fund account and can, therefore, only be used for major repairs and on-going maintenance of the building and its fabric.
