Item for decision

Summary

1 The purpose of this report is to update Members on recent developments regarding the Greenways Play area and to seek approval to undertake a formal survey of the residents in the area regarding the reinstatement of a play area.

Recommendations

2 That Members agree to a residents' survey being carried out to determine whether or not the majority of residents wish to see a play area reinstated or not.

Situation

- A report was submitted to the Community Committee in June 2007 informing Members that the play area at Greenways had been closed due to health & safety reasons and that the equipment would be removed. It sought approval to transfer the land to the Saffron Walden Town Council (See Appendix 1)
- 6 Members approved that the land should be leased to the Saffron Walden Town Council and that the reinstated play area would become the responsibility of the Town Council. Approval was also given to the sum of £20,000 being passed to the Town Council for the installation of the play area as this would have been the sum that was contained in the original Section 106 Agreement. The play area with the sum of £20,000 would have transferred to the Saffron Walden Town Council when it was constructed had there not been a dispute at that time.
- 7 Additionally, the Committee subsequently endorsed the Uttlesford Play Strategy application to the Big Lottery seeking approximately £200,000 for seven portfolio projects which included the Greenways play area.
- 8 The Uttlesford Play Strategy application was approved and there is now £20,000 available for the development of the play area.
- 9 A previous Committee report suggested that officers undertake a consultation exercise to establish if the play area was required by local residents. Members took the view that district should not lose any play areas and that the play area should be reinstated without going through a consultation process.
- 10 However, a resident of Greenways has written to the District Council outlining some of the problems that occurred when the play area was in situ and requesting that another play area is not constructed on that particular site. (See resident's letter at Appendix 2)
- 11 The resident states that the neighbours have been consulted and that the majority of residents either do not want to see the play area reinstated or have no particular views. Whilst it was very proactive of the resident concerned to undertake a survey, officers are concerned that residents might have found it difficult to respond to a neighbour taking the stance that the play area should not be reinstated. Therefore, with Members' approval, it is proposed to undertake a formal consultation exercise within Greenways to establish the way forward.
- 12 With regard to the Big Lottery funding of £20,000 that is available for this project, officers have consulted with Lottery representatives to establish what would happen if the play area was not reinstated. The response is that it will probably be possible to divert this funding into one of the other capital projects so it is unlikely that Uttlesford will lose the funding.



Dear Ms Bradley,

Further to my letter dated 28 January 2008, I would like to let you know the feelings of the Greenways residents concerning the possible re-introduction of a play area on the Greenways green.

Last weekend, I went round to each of the 25 Greenways houses and asked each household their opinion. The result was as follows:

- Against a play area 12
- For a play area 5
- For a play area if under 5s only 2
- 50/50 couldn't decide 2
- Out (on several occasions) 3
- Empty 1

As you can see, virtually 50% are against the re-introduction of a play area with another 2 households only favouring one which was for under 5 year olds.

I have enclosed a photocopy of the petition that I prepared with the signatures, names and house numbers of those who are opposed to any re-introduction of a play area.

I sincerely hope that this, together with my previous letters to you, will emphasise the strength of feelings here in Greenways. A play area of any description would be unwelcome in Greenways for all the reasons already stated in previous correspondence. We wish to remain a quiet, respectable, law-abiding residential area. Please keep it that way.
