Title: Red Payphone Box review by BT

Summary

Author:

1. BT are seeking to rationalise those Payphone Boxes in the community that are not well used. They have identified 45 phones that meet the criteria. The consultation exercise identified that there was support for removal of three phones. BT have listened to our objections to the removal of the remainder and agreed that 12 of them will stay. The remaining 30 have been made available for adoption or sponsorship by Parishes. Some Parishes have progressed their wish to adopt. The District council must now release their objections to permit the Parishes to proceed.

Recommendations

- 2. That Members identify if any of BTs decisions that should be challenged and the reasons for doing so on an individual site basis and,
- 3. That Members withdraw all remaining objections to allow Parishes to proceed with their applications to adopt or sponsor their chosen sites.
- 4. That the Councils statement of its final decision is signed off by Director of Operations in consultation with the Chair of Community Committee and the Leader of the Council.

Situation/Update

- 6. As part of BT's Universal Service Obligation it is required to provide adequate coverage of public payphones however the needs of consumers have changed drastically with the increase in mobile phone ownership leading to a complete change in the communications culture throughout the UK. In 2008 ninety nine per cent of UK homes now have a phone at home, 85 per cent have a mobile phone and in the previous two years the number of calls made from BT Payphones has halved. The demand, and usage, is just not what it was and therefore BT reviewed its public payphone provision so that it aligns closely with the demand that still exists.
- 7. BT are seeking to rationalise those Payphone Boxes in the community that are not well used. The running cost to BT of each payphone is £1,673 and this is not sustainable where usage is low. They identified 45 phones that meet the criteria and consulted the community via the District Council.
- 8. Members and Parish Councils were circulated the following documents on 17 October 2008, from the Director of Operations.

Three sets of documents were attached:

- Uttlesford's response to the consultation
- BT's decisions
- Adopt a Kiosk/Sponsor a Kiosk option

- 9. The consultation exercise identified that there was support for removal of three phones. BT have listened to our objections to the removal of the remainder and agreed that 12 of them will stay. The remaining 30 are available for either adoption or sponsorship by Parishes. Some Parishes have progressed their wish to adopt. The District council must now release their objections to permit the Parishes to proceed.
- 10. This Committee are now asked to withdraw their objections to the removal of payphones to permit Parishes who are seeking to adopt or sponsor a red box to progress. Should the Committee feel they wish to challenge BTs decisions, objectively justified and proportionate reasons (required by s49 Communications Act 2003) are required in addition to those reasons submitted and defeated by BTs response.
- 11. At this point, if the council objects to any phone boxes being removed it is exercising its **local veto**, and those boxes are not then removed unless a Competition Appeals Tribunal decide they should be.
- 12. Of coms advice is that we take into account factors such as:
 - The type of local housing around the box (whether residents are likely to have home or mobile phones) and number of households with 400 metres of the box (where there are few it might be difficult to access another telephone)
 - How much it is use by passing traffic on a busy road, or by bus or train passengers at a busy terminus
 - How likely the phone is to be used for calls to emergency services (for instance in an accident black spot)
 - What the phones takings are (BT has provided the number of calls made from each over the last year)
 - Where there is poor or sporadic mobile network coverage in the area.
