Background

- 6. Sheltered Housing sites have increasing numbers of mobility scooter users due to an expanding aging population. The Council acknowledges the need for independence of living and encourages the use of scooters to improve the standards of independence and mobility to avoid unnecessary stress and isolation. Damage caused by scooter users to Council property and buildings is currently funded by the Council's repairs department.
- 7. Scooters are currently being stored and charged in communal areas and under stairwells in the sheltered schemes. This is in breach of the Fire Regulatory Reform Order 2005.
- 8. To charge a scooter the cost implication is between £2.50 and £3.50 per charge. This can not be monitored in communal areas and is beginning to amount to a considerable cost to the Council as the number of mobility scooter users is rising.
- 9. The Council has insufficient funds in its budget to pay for the shelter and storage facilities for mobility scooters users and the DDA advises that people can store scooters in their individual properties therefore the policy offers an option of outside storage and charging which is self funded.
- 10. Individual surveys are required due to the location and individuality of the sites. For example some sites are listed and in conservation areas. Some schemes may not have lifts which accommodate scooters to upper floors therefore the facility would be required.

Current Situation

- 9. At present the Council has no policy in place regarding the storage and charging of mobility scooters.
- 10. Demand for mobility scooters is increasing yearly.
- 11. The damage to property by scooter users is also rising and the need for insurance is required to cover the cost for damage.
- 12. Tenants are unaware of what is required of them when using a mobility scooter as there is no policy.
- 13. Tenants are currently charging and storing scooters in communal areas adding further costs to the Council.
- 14. With no policy in place the Council's position regarding mobility scooter usage, storage and charging in its buildings and grounds is currently unmanaged and potentially hazardous.

Feedback from Consultation

15. Consultation was carried out with the Tenant Forum, Disability Forum and Sheltered Housing Task Group and comments were received via e-mail and discussion. The legal department were consulted and benchmarking with other authorities took place. The policy was placed on the internet for external consultation. The overall feedback received was that a policy needed to be in place so there is an understanding of the Council's requirements for usage of mobility scooters in its schemes and buildings. There was no negative feedback on the overall policy requirements.

Summary

- 16. The policy is aimed at people with impairments and the aging population who may require the use of a mobility scooter. The policy:
 - Ensures that residents who own a mobility scooter have a clear understanding of their usage in Council properties and buildings
 - Explains the process in applying for storage and charging facilities and why it
 may not always be possible to provide these
 - Advises on the need for insurance and proof of cover
 - Advises on the importance of training and safety with regard to usage
 - Explains options available for people who can not access their individual property because of the design of the property
