### 1 STATEMENTS BY MEMBERS OF GREAT DUNMOW TOWN COUNCIL

Messrs Douglas James and John Davey from Great Dunmow Town Council, made a statement prior to the commencement of the meeting. Summaries of the statements and the Council's response are attached as an appendix to these minutes.

#### 2 OUTGOING CHAIRMAN

Councillor D M Miller, the outgoing chairman, said that his time in this office had been gratifying, interesting and also entertaining. He had tried to promote the district in the best way he could. At the Council meetings he had hoped to curtail unnecessary discussion and felt he had only been partially successful in this, although he realised the need for councillors to "blow off steam". He had, though, been pleased that there had not been too much political dissension during the meetings. For the future, he hoped that Members would refrain from dismissing a good suggestion just because of where it came from.

Councillor Chambers thanked Councillor Miller for being an excellent Chairman and a great ambassador for the district.

## 3 **ELECTION OF CHAIRMAN**

It was proposed by Councillor Mrs Caton and seconded by Councillor R B Tyler that Councillor R P Chambers be appointed Leader of the Council. Councillor Tyler said that Councillor Chambers had worked with exemplary dedication through what had been a difficult year.

It was proposed by Councillor P A Wilcock and seconded by Councillor Mrs E Tealby-Watson that Councillor Gayler be appointed Leader of the Council.

RESOLVED that Councillor R P Chambers be appointed Leader of the Council for the ensuing year.

#### 8 APPOINTMENT OF DEPUTY LEADER

It was proposed by Councillor R P Chambers and seconded by Councillor Mrs M A Caton that Councillor R B Tyler be appointed Deputy Leader of the Council.

RESOLVED that Councillor R B Tyler be appointed Deputy Leader of the Council for the ensuing year.

### 9 APOLOGIES

Apologies for absence were received from Councillors Mrs C A Bayley, R J Copping and R C Smith.

### 10 CHAIRMAN'S COMMUNICATIONS

Councillor Gregory said that he hoped to promote the district at every opportunity and, as he was Chairman for the whole of Uttlesford, he would like to be seen out and about as much as possible. There would be an act of worship and dedication for his chairmanship at the Holy Cross Church, Felsted on Sunday 27 May at 10.30am. He hoped to be able to worship in as many different churches as possible during the year.

He would be supporting two local charities, the Buffy Bus and ResCu. Possible events were a sponsored walk, a quiz, a sponsored visit to every pub in Uttlesford and busking. He would like to give as prizes products that are made in Uttlesford. He finally mentioned the Festival of Young Musicians 2001 to be held in Thaxted church on 25 May 2001 and hoped Members would support this.

### 11 COMMITTEE STRUCTURE 2001/02 TO 1 SEPTEMBER 2001

The new committee structure was to be introduced from September 2001. Following the decision taken on 24 April, Members were therefore asked to continue the membership for the existing committees for the next cycle of meetings.

#### STATEMENT BY MEMBERS OF GREAT DUNMOW TOWN COUNCIL

## **Douglas James**

Councillor Douglas James spoke to the resolution passed by Great Dunmow Town Council, concerning the recent decision taken by Essex County Council not to be maintain Redbond Lodge elderly persons' home, against the county officers' recommendations.

The Town Council believed that Councillor Chambers had influenced county Members to vote in favour of retaining Stanley Wilson Lodge in his capacity as County Councillor for Saffron Walden. As Leader of Uttlesford District Council, he had a responsibility to represent the whole district, and as he had not done so, the Town Council considered that he should resign.

### John Davey

Councillor John Davey was concerned at the disproportionate power and influence of the Leader of the Council. He asked the Council to consider changing its Leader of the Council more frequently.

### Response by Chairman of the Council

Councillor Miller replied that it was up to Uttlesford Members to decide who the Leader of the Council should be. He also felt that the Town Council overestimated Councillor Chambers' influence on County Council members.

Councillor Chambers said that he would reply direct to the Town Council and issue a press release in response to the statement.
