Summary

1. This report assesses the merit of retaining certain appointments to external bodies as conferred on members by the council.

Communication/Consultation	Opportunities for communication with the council other than via a member representative may be taken into account when assessing the validity of an appointment. There may be a role for streamlining contact if regular communication has been held with both officers and members. In some cases, the issue of substituting a bulletin for representation could be considered.

Ward-specific impacts	Ceasing representation on external bodies whose objectives are ward-specific may have an impact on that ward, which should be taken into account in these cases. The majority of appointments to external bodies are non-ward specific.		
Workforce/Workplace	Minimal, as the majority of appointments will be retained, resulting in little change to officers' associated time.		

Situation

- 5. There are 63 appointments to external bodies conferred on members by full council. The majority of appointments are for a single representative, but there are a few appointments requiring a substitute to be named, or requiring two substantive appointments. In total, members dedicate significant time to work relating to such appointments. Current appointments set by full council range from the obligatory (whether a statutory or similar duty, or because necessary from a strategic point of view), to those which are desirable for various reasons, and finally to those which may for various reasons be redundant. It is therefore recommended that the council consider whether there are any appointments to external bodies which may be discontinued on the grounds set out at paragraph 7 below.
- 6. In taking a view on whether or not to keep a post, a decision will depend on factors such as whether the post is agreed to be a valid use of the appointee's time; and the basis for making a distinction between those local organisations which currently benefit from having a member representative, and those which do not. It should be noted that questioning the validity of the appointment is not intended to reflect adversely on the value of the role played by the external body itself.
- 7. The grounds for deciding whether to retain, further assess, or discontinue appointments have been formulated as follows.

 Group 1 – appointments which are recommended to be retained on the following grounds: for strategic reasons; where the council has a statutory responsibility; where there is a service level agreement; where the constitution of the external body unavoidably requires member representation; where the member has recommended continued representation.

Group 2 – where the merits of continued councillor representation are to be considered on the following grounds: where there are other routes of communication between the council and the external body via local authority groups which may duplicate the link; where there is frequent officer contact with the external body; where representation seems to have been established primarily to gain access to funding; where representation reflects a relationship based primarily on the leasing of premises from the council.
