## Summary

#### Situation

- 1 When the Oakwood Park development was constructed it contained a Community Hall and a Play Area. Currently, due to defects, the Community Hall has not been accepted by the District Council. However, the Play Area was taken over by the District Council approximately a year ago with the aim of transferring it to the new Parish Council in the future.
- 2 The Play Area at Baynard Avenue has been looked after by the District Council with support from the Deputy Town Clerk from Great Dunmow who has the appropriate qualifications to monitor play equipment. The District Council does not have the expertise to monitor play areas and does not own or control any other play areas.
- 3 Recently, the slide was removed as it proved to be dangerous and the Parish Council is willing to replace the slide.
- 4 Therefore, following considerable discussions Flitch Green Parish Council has now agreed to take over responsibility for the Play Area. Approximately £4,000 remains from the commuted sum for the maintenance of the Play Area and this sum should also be transferred to Flitch Green Parish Council.
- 5 With Members' approval to this course of action the Solicitors will draw up the appropriate legal documentation to discharge the District Council of this responsibility.
