"It is proposed that a letter be sent from this council to the Prime Minister to thank him and the new coalition Government for honouring the pre-election commitment on airport expansion it gave to the residents of Uttlesford and surrounding area and for the early announcement that it will not allow a second runway at Stansted Airport leading to the withdrawal of the planning application for a second runway.

It is also proposed, that included in this correspondence is a request to Phillip Hammond MP, the new Secretary of State for Transport, to ensure that any new government policy on aviation or airports includes a binding commitment that residents of this area will not again have to experience the blight created by the Aviation white paper in 2002.

The 2002 Aviation white paper resulted in eight years of uncertainty for many people with a number of local residents facing the realisation and trauma of losing their homes therefore it is respectfully suggested to the Secretary of State that a moratorium on a second runway at Stansted Airport be in place for a period of fifty years."
