#### Summary

 New appointments have been made to the Independent remuneration Panel since the last meeting. Details of the appointments are given in the body of the report. # Situation

- 6. At the end of July, David Murtagh retired as a member of the Independent Remuneration Panel after four years' service. David Barron is due to retire from the Panel in April 2013.
- 7. The immediate position was advertised in June with a view to appointing a second applicant to a shadow position to avoid incurring further advertising costs.
- 8. Four applicants were interviewed for this position at the end of July. The immediate position was offered to and accepted by Mrs Jacqueline Anslow of Great Dunmow for a four year term of office beginning on 1 August 2012. It was decided to offer a shadow position to Mrs Janet Pearson of Debden until April 2013 when she will replace David Barron.
- 9. The other member of the Panel is John Nowell of Saffron Walden who was appointed for a four year term of office last year.
- 10. The allowances scheme makes no provision for shadow payments. Mrs Pearson was appointed on the basis that she would receive payment of £250 (half of the normal rate) during the period that she serves as a shadow member subject to agreement by Full Council.
- 11. Members are therefore asked to ratify the payment of £250 to Mrs Pearson.
- 12. The new Panel met for the first time on 26 September and has now commenced the review of members' allowances for the year 2013/14.
