Reason:- To assess the impact on neighbouring properties and on the setting of the green in an area of special landscape value.

Mr Gibbs spoke against the application. Mr Patmore from Clavering Parish Council spoke in support of the application.

1653/02/FUL Stansted – two storey dwelling with double garage – rear of 22 Park Road for J A Young.

Reason: To assess the impact of the development on neighbouring properties.

Mr Young spoke in support of the application.

1857/02/FUL Stansted – Side and rear extension – 37 St Johns Crescent for Lisa Marie Lally.

Reason: To assess the impact on the neighbouring property to the north.

Councillor Mrs Loughlin left the meeting for the consideration of this item.

DCL175 PLANNING APPEALS

The Committee noted the following appeal decisions.

- (i) Dwelling with granny annexe, associated landscaping and access improvement to replace all existing buildings and uses The Old Piggeries, Cornells Lane, Widdington (0648/02/FUL) Allowed.
- (ii) Four one bedroom flats for residential use 48 (rear) Silver Street, Stansted (0365/02/FUL) Allowed.
- (iii) Planning permission and enforcement action regarding a wall to front garden and lamp standard Woodnut, Bacon End Green, Great Canfield (1434/01/FUL) Allowed.
- (iv) Detached garage block with fitness room and home office and studio (0761/02/FUL) Dismissed.
- (v) Replacement of historic windows Saffron Walden Almshouses, Abbey Lane (0240/02/LB) Dismissed.
- (vi) Vehicular crossing from Lower Street The Porch, 29 Lower Street, Stansted Mountfitchet (1235/02/FUL) Dismissed.
- (vii) Removal of builders yard and associated buildings and erection of one detached house and garage Land adjacent to Burnt House Farm, Stebbing Green, Stebbing (0436/02/OP) Dismissed.

Members were concerned at the Inspector's decision in respect of the Old Piggeries, Cornells Lane, Widdington. The Head of Planning and Building Surveying suggested holding a workshop to discuss the supplementary planning guidance on this matter. This was agreed to be held at a subsequent meeting in the early summer.

DCL176 PLANNING DELIVERY GRANT

The Chairman agreed to the consideration of the following item of business as a decision was required before the end of the financial year.

The Committee was advised of the distribution of the Planning Delivery Grant (PDG) announced by the Government, which would make an additional £350m available to local authorities over the period 2003 – 2006. Uttlesford had been awarded a grant of £246,261 for 2003/04 which reflected the improved Development Control performance between June 2001 and June 2002. The report before the Committee set out the priorities that officers considered at this stage would improve service delivery.

- The appointment of independent consultants to carry out the Best Value Review of Planning Services.
- Bringing forward the appointment of new staff following the approved restructuring of planning services
- Funding the employment of temporary staff to reduce 'pressure points' in workload
- Improvements in IT
- Staff and Member training
- Outsourcing handling of planning appeals and considering of outsourcing certain categories of planning applications.
- Technical and administrative support for the enforcement service.

The Committee agreed with these suggestions and thought that a high priority should be additional staff resources for the enforcement service. Reports would be brought back to Members on how this grant would be allocated. Councillor Thawley cautioned that outsourcing of work might not necessarily be cost effective.

RECOMMENDED to the Resources Committee that officers prepare a costed improvement and development plan for implementing the proprieties listed above to take maximum advantage of the grant resources available.

DCL177 **EXCLUSION OF THE PUBLIC**

RESOLVED that under Section 100A of the Local Government Act 1972 the public be excluded for the following items of business on the grounds that they involved the likely involvement of Exempt Information as defined in paragraphs 12 and 15 of Part I of Schedule 12A of the Act.

DCL178 OMBUDSMAN REPORT – THAXTED

The Committee was advised of the outcome of a recent Ombudsman case.

DCL179 ENFORCEMENT OF PLANNING CONTROL - PROGRESS REPORT

The Committee received the report setting out the outstanding enforcement cases. The following items were updated:

(i) Martinside Stud, Ladywell Drive, Little Hallingbury

The date for compliance was now 28 March 2003. The site would be inspected on 30 March 2003 and committal proceedings would be taken if necessary.

(ii) Woodcroft, Stortford Road, Little Canfield

The appellants had one further week in which to comply.

(iii) Land adjacent to Little Paddocks, Cutlers Green, Thaxted

Compliance had been achieved.

(iv) Willow Farm, Braintree Road, Great Dunmow

Compliance had been deferred until March 2004.

(v) Land at Brick End, Broxted

A date for direct action had been fixed.

(v) Fairview Homes, Radwinter Road, Saffron Walden

Compliance had been achieved.

DCL180 RELEASE OF PART OF SECTION 52 AGREEMENT LAND AT GRANSMORE GREEN, FELSTED

The Committee was asked to approve the variation of an old planning agreement.

RESOLVED that the Section 52 Agreement be varied by deleting the prohibition on planning applications, subject to the owner meeting the Council's Legal costs.

Councillors R B Tyler, Mrs M A Caton, R A E Clifford, R D Green, P G F Lewis and A R Thawley attended the meeting for the following item.

DCL181 **DETERMINATION OF A PRIVATE HIRE DRIVERS AND OPERATORS LICENCE**

The Committee considered an application for a private hire drivers licence where the applicant did not meet the standard licensing conditions. It also considered whether the applicant's private hire vehicle operators licence should be suspended or revoked under Section 62 of the Local Government (Miscellaneous Provisions) Act 1976.

The Chairman explained to the applicant the procedures to be followed in considering the application.

The Council's Licensing Officer explained the reasons why the application had come before the Licensing Committee. The applicant was invited to question the Licensing Officer and to comment on the accuracy of the Licensing Officer's report. The applicant was then invited to answer the observations of the Council's Licensing representative and give reasons in support of his

application. The licensing representative then asked questions of the applicant as did Members at the invitation of the Chairman.

The applicant made a final statement and confirmed that he had said everything he wanted to say and he had nothing further to add. The applicant and the Licensing Officer then left the meeting and the Committee considered its decision. The applicant was later readmitted and informed of the decision. He was advised of his rights to appeal to the Magistrates Court within 21 days.

RESOLVED that

- The Private Hire Drivers Licence be not granted because the applicant was not a fit and proper person to hold a licence, as he had allowed children to be driven in an unlicensed vehicle with an unlicensed driver and therefore there was not the opportunity for the appropriate police checks to be carried out.
- The Private Hire Vehicle Operators licence be revoked because of a conviction for an offence under the Local Government (Miscellaneous Provisions) Act 1976.
- 3 Councillor R B Tyler be nominated to represent the Council at the Magistrates Court, should an appeal be lodged.

The meeting ended at 6.35 pm.
