Pre-trial scheduled for 26 November 2004. Trial fixed for 19 April 2005. Defendant found guilty. Fine imposed of £3,000 plus costs. Appeal to High Court (case stated).
2	Land in Cock Lane, Starlings Green, Clavering	Non-return of Requisition for Information regarding unauthorised business use of smallholding building Summons issued. Defendant pleaded not guilty at first hearing. Defendant pleaded guilty at second hearing (21/3/06). Court costs awarded to Council. Defendant given one year conditional discharge.
