An associated application for costs against the Council was rejected except in as far as an administrative error involving failure to notify third parties of the hearing. The amount has yet to be agreed but is likely to be small. (GB)

The Inspector concluded that appellant's claims for a longer period were not supported by any evidence and wholeheartedly supported the Council's view that the appellant's conflicting claims about the amount of storage undermined the company's claim for a longer period.
