Summary

- 1. The draft Planning Enforcement Strategy has been prepared by officers from Enforcement, Legal and Planning and has been adapted taking into account comments from Councillors in a recent planning workshop.
- 2. The document sets out the background to planning enforcement, the enforcement tools available to the Council, the procedure by which the Council will consider action, the priorities the Council will give to different breaches of planning control, and the potential outcomes for breaching planning control.

Recommendations

- 3. That a six week consultation process on the Planning Enforcement Strategy be undertaken to invite comments on the document from Town and Parish Councils.
- 4. At the close of the consultation a report setting out comments on the Planning Enforcement Strategy will be prepared, together with any suggested changes to the Strategy. This will be subject to Member approval and adoption.

Situation

- 8. Planning enforcement is a high profile part of the Councils activity. As with general planning it is very emotive and very personal. It is therefore important for the Council to have a clear and robust strategy for handing planning enforcement complaints.
- 9. The draft strategy sets out the background to planning enforcement, the enforcement tools available to the Council, the procedure by which the Council will consider action, the priorities the Council will give to different breaches of planning control, and the potential outcomes for breaching planning control.
- 10. This clear strategy will aid members of the public understand the role of planning enforcement, understand some of the limitations and understand that the Council must take a proportionate approach to dealing with complaints. It is important to remember that planning enforcement is not about punishing those who have carried out unauthorised work; rather it is there to rectify any harm caused. Planning enforcement is discretionary and therefore in some circumstances the Council decides that it is not expedient to take further action.

- 11. In all cases having a robust strategy to follow means that the Council clearly sets out its priorities which making it clear that these are based on available resources and harm caused.
- 12. To ensure that the Council gains the widest possible buy in to the strategy it is important to consult the Town and Parish Councils for their views. This report seeks authorisation to initiate a 6-week consultation.
- 13. At the close of the consultation a report setting out comments on the Planning Enforcement Strategy will be prepared, together with any suggested changes to the Strategy. This will be subject to Member approval and adoption.
