Situation

- The Core Strategy is one of the key documents in the new Local Development Framework for Uttlesford and the first Development Plan Document to be prepared. It will set out the long-term vision and objectives for the district including broad policies for steering and shaping development and identifying broad locations for new housing growth as well as defining areas which should be protected.
- The consultation document forms part of a series of consultation exercises with the aim of identifying the issues facing the district and the possible options to meet these issues. The consultation period will last for 6 weeks from mid/end January.
- The first part of the consultation document will set out a proposed vision for the District up to 2021. It will then set out suggested objectives for achieving the different elements of the vision and suggest the sort of policies which might be needed in the Core Strategy to meet those objectives. The Council is seeking views on the suggested objectives and the need for particular policies and whether there are other objectives and policies which should be included.
- The second part of the document will set out a number of options that could be used either on their own or in various combinations to deliver the housing growth that will be required in the District up to 2021. Views on this key aspect of the Core Strategy are very important to the Council.
- The spatial options generally fall into two types: either concentrated growth where the growth is accommodated in a single or small number of locations; or a more dispersed growth over a larger number of locations. To be in conformity with the East of England Plan the option of providing for 'No Growth' cannot be pursued.

Concentrated growth options

- Concentrate all development at Saffron Walden
- Concentrate all development at Great Dunmow
- Concentrate all development at Stansted Mountfitchet
- Concentrate development at the largest centres of Great Dunmow, Saffron Walden and Stansted Mountfitchet

- Concentrate Development in a single new settlement
 Dispersed growth options
- Distribute development over a hierarchy of settlements from villages with services and facilities through key rural centres to largest settlements
- Distribute Development along the West Anglia Rail corridor
- Distribute all development in villages around the District
- Distribute development along the A120 corridor and in Dunmow
- When the Council has considered all the responses to this document it will prepare another document for consultation which will refine the ideas set out here into a set of preferred options. This will then be subject to further consultation in the autumn of 2007 and then a final submission draft will be prepared for submission to the Secretary of State in March 2008. An examination into the soundness of the Core Strategy will take place in September 2008 before it can be finally adopted in 2009.
