## PROPOSAL FOR BOUNDARY CHANGE: BIRCHANGER AND STANSTED

## **Proposal**

To transfer the entire Foresthall Park estate to SM, the existing boundary with the parish of Birchanger to be realigned from the existing boundary at Gipsy Lane to follow a line north-easterly to the junction with Stansted Road, then in a southerly direction to the junction with Forest Hall Road, then following the centre of that road for nearly its entire length almost to the junction with Parsonage Lane, then following a line to the rear of the properties known as 1 and 2 Parsonage Farm Cottages, in a southerly and then easterly direction, thus keeping these properties within Stansted Mountfitchet parish, to a point where it meets with Parsonage Lane, and then in a generally southerly direction to the existing parish boundary immediately south of Parsonage Farm, keeping that property within Stansted parish. The effect of this change will be to transfer to Stansted Mountfitchet everything lying to the north of Forest Hall Road including properties at Pines Hill.

Residents were asked to complete a voting form electing either in favour or against the proposal. Results were as follows:

# IN FAVOUR OF THE PROPOSAL

54 voting forms were received in favour of the proposal with no additional comments

Two voting forms were received in favour with the following comments:
