EWG1 **ELECTION OF CHAIRMAN**

Councillor Chambers was proposed and duly elected as Chairman.

EWG2 APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST

Apologies for absence were received from Councillor Freeman.

EWG3 **MINUTES**

The minutes of the meeting held on 30 May 2013 were received and signed by the Chairman as a correct record.

EWG4 WORK PROGRAMME 2014/15

The Democratic and Electoral Services Manager summarised key elements from the proposed work programme for 2014/15. The programme would include the polling district review; consideration of the scale of Returning Officer's fees at district and parish elections and consideration of a programme of Community Governance Reviews (parish reviews) in the next two years.

The Democratic and Electoral Services Manager said this was a rolling programme, due to the challenge of scheduling an onerous level of work whilst the department was also dealing with the new individual electoral registration system, and preparing for the May 2015 elections. It was likely there would be a number of contentious development sites coming forward which would require review. It was therefore probable that the community governance review would have to be undertaken after the new council was returned, and in due course a timetable for the work would be prepared for members' agreement.

EWG5 REVIEW OF POLLING DISTRICTS, POLLING PLACES AND STATIONS

The Democratic and Electoral Services Manager presented a report seeking members' approval of the timetable, process and terms of reference for the review of the polling districts and places to be carried out.

This was a statutory review, which had to be completed by the end of January 2015. However, following the new boundaries implemented by Parliamentary Order following the Further Electoral Review in 2013/14, this review would in any event have been necessary.

The boundary changes primarily affected Saffron Walden and Stansted wards, and to some extent Dunmow.

The Democratic and Electoral Services Manager said that due to the tight timetable for the polling district review, the consultation had started the previous day. He asked Members to agree terms of reference as set out in Appendix C, updated to reflect the timetable to be considered at this meeting.

AGREED to adopt the terms of reference as set out in the appendix.

The Democratic and Electoral Services Manager said whilst limits on staffing capacity would mean not all polling districts and places could be visited, visits would be made to all where representations had been made. He referred members to the draft scheme set out in the report, an updated version of which was circulated to show the figures calculated for the revised ward boundaries.

The Democratic and Electoral Services Manager drew attention to a list of 'problem areas' which would need consideration. Proposals would be drafted after responses to the initial consultation had been received, and would be brought to the next meeting. There would then be a further consultation period. Members would then meet again, to make recommendations to Full Council. The changes would be published and implemented in the new electoral register on 1 December 2014.

The Chairman thanked the Democratic and Electoral Services Manager and invited members to comment.

Councillor Dean expressed concern at the short consultation period allowed for in the timetable, as parish councils tended not to have meetings during August.

The Chairman agreed, and asked whether the timetable could be extended.

The Democratic and Electoral Services Manager said all representations would be considered, even if received after the deadline for the consultation. The review could not be started earlier due to staff workload. Nevertheless there would be a thorough review as the process included a second consultation period. The recommendations following the consultation had to be approved by Full Council, so the scheduled meeting of Full Council on 21 October 2014 had seemed the most likely opportunity for this to be done. However, if members wished, an extraordinary Full Council meeting could be called in order to allow for an extended timetable.

The Chairman suggested the possibility of recruiting additional staff and said funding could be made available for this purpose.

The Democratic and Electoral Services Manager thanked the Chairman and said additional resources had been obtained, and he was satisfied there was currently sufficient capacity.

Further discussion of the timescale took place. It was noted the Polling District Review timetable was imposed nationally, and the new scheme had to be in place by the end of January 2015. In the case of Uttlesford, the changes agreed under last year's Further Electoral Review would at the same time be implemented in accordance with the Order finalising that process, which had been made on 20 May 2014.

Councillor Davey asked about parish boundary changes arising from development in "sector 4" in Dunmow. He was concerned that as occupancy of new developments increased, boundaries ought to be resolved at the appropriate time.

The Democratic and Electoral Services Manager explained that under a community governance review it was necessary to consult those people who were most likely to be affected by the changes, in order to reflect community identities. It was therefore preferable to wait until occupants were living at the sites.

Councillor Dean asked about issues affecting wards in Stansted.

The Democratic and Electoral Services Manager said inevitably there would be changes to polling district boundaries in Stansted, and also in Saffron Walden, due to imbalances in the numbers of voters following the ward boundary changes. As a general rule, it was advisable to limit numbers of voters for each polling district to no more than 3000.

AGREED to revise the timetable to allow a longer consultation period.

The next meeting would be at 5pm on 18 September 2014.

The meeting ended at 7.40pm.



Another key factor to consider when assessing the suitability of a particular building or location is the facilities available to polling station staff. It must not be overlooked that the staff will be on duty for approximately sixteen hours, and that they will not be permitted to leave the premises. Their basis human needs must not be discounted. Issues to consider include the provision of:

- Adequate toilet facilities yes
- A kitchen, or at a minimum, access to tea and coffee making facilities yes
- Adequate heating/cooling yes
- A separate area adjacent to the polling station where breaks could potentially be taken yes
- A telephone no but adequate mobile coverage
- Comfortable adult chairs ves

REVIEW OF POLLING PLACES DUDDENHOE END VILLAGE HALL

Duddenhoe End Village Hall is situated in the centre of the village, adjacent to a bus stop.

There is a dedicated car park to the rear of the building, approximately 25m from the front door. There is not a 'marked' designated disabled parking space, however one could be provided.

There is a wide flat path from the car park to the front door, which is suitable for buggies and wheel chairs. There are no severe gradients. There is adequate lighting once the hall lights are switched on; the external lighting to the hall from the disabled ramp to the front door is scheduled for improvement during 2014/15. The car park lighting was improved in 2012/13 with the installation of a PIR.

There is a flight of steps to the front door with a hand rail and adequate lighting. The door are light and easily opened. The external lighting to the entrance will be upgraded as detailed above. There is a well-lit separate disabled access with a ramp and handrail via the doors at the side of the building.

Once inside the building there are no internal steps or barriers for visitor to negotiate. There is a doormat which is level with the entrance. The hall floor is a traditional wooden floor and does not become slippery when wet. There are no corridors which are difficult for any user to negotiate. There is adequate lighting in the hall for the purposes of a polling station, there would be no need for any additional lighting.

With regard to facilities for polling station staff;

- There are separate male and female toilets and a separate disabled toilet facilities.
- A kitchen with kettle, microwave oven, fridge, freezer and oven. Crockery and cutlery are available for use.
- There are heaters in the hall and all windows can be opened.
- The kitchen area can be used for breaks.
- There is no telephone, mobile signal is unreliable however there is a public call box, 100m from the hall, which does not take coins.
- There are sufficient chairs suitable for adults.

Background:

Great Canfield Village Hall has been the village polling station for many years.

It is owned by the PCC and currently managed and run by a village charity The Great Canfield Community Trust which holds a lease.

Location:

The Hall is centrally located at the junction with the principal road through the Parish and is easily accessible from all parts of the Village. It has direct access from a minor road.

We have no pavements or public transport in the village.

Parking:

There is a car park directly adjacent to the Hall. Electors have to walk no more than a few paces on level compacted ground. There is no designated disabled parking space although plans to provide one are being considered. A spray marked temporary disabled space could be created.

Access:

The building has a permanent ramp marked with edging white lines for greater visibility and a handrail

Able electors have an alternative of two similarly marked steps.

Internally the hall is readily accessible for wheelchair users or those with mobility problems.

There is an easily negotiable well lit lobby area. One internal door would be required to be kept open.

There are no internal steps or barriers, level matting and a slightly raised threshold to the hall door(c. ¾") No other trip hazards.

There is a wooden floor. There is no experience of it becoming wet or slippery.

Electors would have travelled over several yards of matting before they encountered the flooring.

General:

The hall is large, well lit throughout ,and in the past has comfortably accommodated polling equipment, electoral staff, and electors. There is ample space to accommodate wheelchair users. As above – it has wooden flooring throughout.

Staff:

There are both male & female toilets; a well equipped kitchen; good heating, and a supply of chairs. There is no landline telephone.



Futhermore, we have a disabled toilet. We have parking for 3 or so cars and alternative parking is available close by in Mill Lane. The approach is tarmac and does not have any gradient. In reply to the recent correspondence regarding Polling Districts and Polling Stations, we would like to state that St Peter's Church Littlebury Green Vestry would still be available as a Polling Station.

Details:

St Peter's is situated in the centre of the Hamlet of Littlebury Green. There is no car park so vehicles park on the side of the road. The church sits close to the road with a short flat path that leads from the road up to a slight ramp which levels flat to the main entrance which has double doors that allow for easy wheelchair access.

The entrance has fixed none slip carpet squares and the floor of the main body of the church is varnished wood.

The Church and Vestry is well lit and heated by mobile Gas & Electric heaters. In the vestry there is a sink with mains cold water. There is a kettle or an urn and crockery for hot drinks but NO COOKER/MICRO WAVE, but a portable single ring gas cooker can be made available.

Toilet facilities is by way of an Elsan Chemical Loo situated in the small shed outside to the rear of the church. Hand washing facilities are provided. This arrangement tend's to suit male officers.

The Polling station is set up with table in vestry which officers sit behind, by keeping the vestry door open the officers have full view of front door, approaching public and voting booths which are placed front left of the building.

There is plenty of public waiting space as they can sit on the pews.

I refer to my telephone conversation of 22nd and 28th January 2013 and I am pleased that you are willing to review the polling station location again but not until after the May election. Also that should the polling station not be returned to the Flitch Of Bacon Public House and for any reason not be suitable it would not move to Flitch Green.

I would like to suggest that the best thing would be to class the Flitch Of Bacon as the first choice and the community meeting room (portacabin) be the second choice. As I explained I have discussed this matter with Mrs Bacon, the landlady of the Flitch Of Bacon who is most willing to have the polling station returned.

There are many disadvantages for the location of the community meeting room being the wrong first choice.

- 1. This is a portacabin which has been vandalised many times and has only recently had a window broken so could on the day of voting not be suitable.
- 2. The location of the portacabin means there is no street lighting or outside lighting.
- 3. This is not central in the village and would not catch passers by on the day of voting. As you know voting is going down every year in numbers so the location for ease is more important now.
- 4. Little Dunmow is spread out over the old A120 in both directions so we should be looking to making the location for voting more central not more remote.

Whilst I do appreciate the Flitch Of Bacon is a licensed premises. The voting has always been set up by separate access at the side and is screened off from the public house inside. I am sure many other villages use licensed premises such as village halls for voting.

Finally I would like to remind you back in 1990 the location was moved for the voting as it has been now and it was found to be unsuitable. I feel very concerned why now all these years on it has now been decided to move it again to the same location that was found then to be unsuitable.

4.10 Schools that are publicly-funded, including academies and free schools, may be used as polling stations free of charge, and the legislation allows you to require a room in such schools for use as a polling station. You are also entitled to use, free of charge, any publicly-funded room as a polling station. You will, however, need to pay for any lighting, heating, etc., costs incurred when using such rooms as polling stations. You should liaise with the relevant schools and managers of publicly-funded rooms at the earliest opportunity to confirm that you want to use certain rooms within their premises as polling stations.

With regard to the letter dated 6th August 2014 on the above subject. I make the following comments on behalf of Ugley Village Hall Committee:

The polling station uses the small hall to the left of the main Ugley Village Hall. This has its own entrance; a ramp with handrail and a widened entrance were installed by Uttlesford a few years ago. There is also a widened doorway to the lavatories, of which one is for disabled use.

The polling place is on a level surface with a large car park. There is a designed disabled parking space close to the ramp. The car park has a gravel surface. There is outside lighting.

There is a bus stop outside the polling station and a dropped kerb close by.

There are no internal steps - there is a mat inside the door which is level with the floor. The floor is treated with a non-slip covering.

The lighting is sufficient and one set of lights is operated by a switch just inside the door.

A kitchen is available with hot drink making and full cooking facilities. There is always heating on in the colder months and windows can be opened with a key which is provided with the door key.

A telephone is not available in the building but there is a public calbox a few yards away.

The Village Hall was subject to a fire inspection recently and various recommendations were put in place with regard to illuminated exit signs, re-location and extra provision of fire extinguishers and extra outside lighting.

I hope this information is sufficient for your requirements. Please contact me if you need further help.
