### Summary

One of the areas of Corporate Focus in the Council's Corporate Plan is a commitment to developing an action plan following its signing of the Nottingham Declaration. There is also has longstanding policy to promote sustainable organisational practice. During 2006-2007, the council will focus on becoming a more sustainable organisation through active energy management, reviewing policies relating to travel and working practices, a sustainable procurement policy and a paper-usage reduction programme. Externally, we will be considering how the effects of climate change may be ameliorated by exploring ways of using /conserving resources such as water. We will also be addressing the opportunities that exist within the planning system to promote or require more sustainable building practices.

The project Team, Championed by Cllr Pedder, has identified that there is presently no budget for the promotion of carbon reduction and sustainable living in general, and it is unlikely that any action plan will be successful if the Council is unable to communicate its message. It is proposed to use Planning Delivery Grant for the remainder of this financial year, and to bid for a budget in the next financial year and beyond. Such a budget could be self financing if savings accrue.

#### Recommendations

That a sum of £15,000 for the promotion of sustainable living and carbon reduction in the District be made available from Planning Delivery Grant for the remainder of this financial year, that the Committee agree an appropriate annual budget for this purpose and that permanent funding be sought thereafter as part of the budget setting for 2007/8 and beyond.

#### **Situation**

- The Council is committed to reduction in carbon emissions and has an energy saving target of 20% by the end of 2006/7 when compared with the position in 2004/5. The Energy Efficiency Surveyor has been making excellent progress in meeting this target as well as increasing public awareness of the need to reduce carbon emissions through seminars, public meetings, attendance at various public events, articles in Uttlesford Life etc. All of these contribute to individuals being aware of how they can reduce energy consumption, reduce carbon emissions and thus reduce their own contributions to climate change.
- In addition the provisions of the Home Energy Conservation Act 1995 require the Council to decrease carbon emissions in the existing housing stock. A Sustainable Council is one of the areas of corporate focus in the Corporate Plan, and the Project Team, championed by Cllr Pedder, meets to develop this project. Amongst the many initiatives developed by the team are to set a sustainable example by reducing the environmental impact of the Council's operations including waste, water and paper, influencing behaviour of residents by communicating the benefits of sustainable living and implementing the Carbon Trust measures for Council premises
- The Project Team has identified a need for a budget in the short term for the publication of a sustainability checklist for residents to tie in with work being done by LA21, and in the longer term to support and "pump prime" various initiatives. It is intended that so far as possible the initiatives would lead to savings for the Council and where possible be self financing.
- It is considered that Planning Delivery Grant should be used for this financial year, and that a budget should be identified for future years.
