Summary

This report is about a proposal by the North London Strategic Alliance (NLSA) to establish a West Anglia Routes Group, which would seek timely upgrades to the West Anglia rail corridor to enhance capacity, improve reliability and promote growth for the benefit of all those who live and work in the London-Stansted-Cambridge-Peterborough Corridor. This Council is invited to Associate Membership of the Group, incurring an estimated fee of £1,250 per annum to cover the Group's running costs and activities.

Recommendation

That Members agree to the principle of the Council becoming an Associate Member of the West Anglia Routes Group. Terms of membership will then be worked up by officers in association with the NLSA.

- 1 The NLSA was formed in 1997 to achieve greater co-operation and coordination between public, private and voluntary sector partnerships to improve economic and social well-being in North London. The interests of the NLSA focus on the boroughs of Barnet, Enfield, Haringey and Waltham Forest and local transport links, but the NLSA does work to support wider objectives for the development of London.
- 2 Seminars with key stakeholders and other interest groups were held in May and August of this year to look at establishing the West Anglia Routes Group. Following these meetings, the attached prospectus was drawn up by the NLSA. Current key events that require the Group's attention would be:

Responding to TfL's Transport 2025 strategy Monitoring progress with the Stansted Generation 1 application Commenting on Network Rail's Greater Anglia Route Utilisation Strategy (RUS) as it emerges, and Trying to influence decisions round the Treasury's 2007 Spending Review.

3 Members will note that the Group would have a broad membership base and by its nature would be London-focussed. It has already been acknowledged at the earlier meetings that reaching a consensus over some priorities and actions may be challenging. Accordingly, it is the view of officers that it would be in the best interests of local rail users for this Council to be represented on the Group
