Summary

 This is the first Budget Monitoring report to this Committee for the financial year 2008/09.

- Performance Select Committee, at its meeting on 29th April 2008 agreed the process for members to separately receive budget monitoring information direct.

 - Appendix A is a briefing note explaining where the figures come from, the principles of profiling budgets, and a guide to the various warning signs via the "faces".
