Title: CAR PARK LIGHTING POLICY - Fairycroft

## Summary

1. A review of the 24 hour lighting policy is required, and a consultation has been undertaken with four key stake holders. A 12 month trail is proposed to turn off, at midnight until 5 a.m., all lights except those on the ground floor which will remain on all night.

#### Recommendations

2. That Members consider the outcome of the consultation exercise, and

- 3. Approve a trial period of 12 months after which an evaluation is undertaken and reported to Members to enable a way forward to be agreed.
- 4. That Officers are authorized to commence a trial in accordance with option 3 -That the lights on the ground floor only remain on all night and the remainder are turned off at midnight until 5 a.m.
- 5. Officers are further delegated authority to curtail the trial without notice should there be deemed a threat to community safety due to this trial and report back to Members at the meeting following this concern.

## **Impact**

Communication/Consultation	A public consultation exercise has been undertaken with the Police Authority, Saffron Walden Town Council, Waitrose and Community Safety.
Community Safety	Any reduction in lighting will cause concern but there seems to be no increase in crime arising from the street lighting hours being curtailed. The view may be taken that if any area is not lit it does not encourage nuisance youths to gather.

Finance	The infrastructure to adjust the timing and provide signs will be around £500 which

### Situation

- 7. The District Council has been approached regarding the level of lighting that may or may not be needed in the multi-story car park and the adjoining open area of Fairycroft car park.
- 8. A consultation exercise has been undertaken with the Police Authority, Saffron Walden Town Council, Waitrose and the Community Safety Officer as key stakeholders.
- 9. Historically the 24 hour lighting policy was established as a community safety measure after a serious incident occurred in one of our car parks some years ago. Press coverage has recently evidenced that the switching off of street lighting has not had the adverse effect on crime that was anticipated.
- 10. The 24 hour car park lighting is visible from elevated parts of the town and has been objected to by near neighbours.
- 11. This multi-storey car park closes (barriers come down) 15 minutes after the Waitrose Store closes, that being Mon Tues Sat 19.15, Wed Thurs 20.15, Fri 21.15 and Sun 16.15. The outside car park remains open.

- 12. The consultation offered the following four options:
  - 1 That the lights in all areas of the car park are on all night (as present)
  - 2 That the lights are turned off at midnight until 5 a.m. (same arrangement as ECC for street lighting).
  - 3 That the lights on the ground floor only remain on all night and the remainder are turned off at midnight until 5 a.m.
  - 4 That the lights on the ground floor only remain on all night and the remainder turn off at 10.30 p.m. until 5 a.m.
- 14. Consultees were also asked if they felt that the level should be generally reduced and invited to make further comment. A copy of the survey and accompanying letter are attached to this report.

## General comments were added by two consultees:

- 16. The view on this matter is that there are clearly two conflicting perspectives:
  - a) turn the lights off and crime/nuisance will increase because it is dark, or
  - b) leave the lights on and criminals/nuisance youths will gather because they can see what they are going

Consequently, it is suggested that all lights are switched off for an agreed trial period at the conclusion of which, an evaluation is made and the way forward agreed.

17. "I would like to see the lighting reduced as in option 3. We have people starting work at 05:00 am to open the branch so would like to see the lights come back on at 04:00 or 04:30 so the area is lit and safe for our partners to come to work."
