Title:	Appointment of a contractor to negotiate a co-mingled recyclable materials gate fee under the exception provision in contracts procedure rules

#### Summary

 An independent company with expertise knowledge and contacts within the recycling market is needed to procure a contract on the council's behalf with a materials recycling facility to buy our recyclable materials. A particular company has been identified with up to date knowledge with the current market in the region and already has established contacts with the recycling companies. It has negotiated a potential contract for another local authority enabling that council to sell its co-mingled recyclables at an attractive rate per tonne. Using this company would enable the council to negotiate a similar contract.

### Recommendations

- 2. White Young Green be appointed to procure a contract on the council's behalf with a materials recycling facility to buy our recyclable materials

### **Financial Implications**

3. The costs need to be established but estimates suggest that the initial fees would be recouped by a significant multiple in year, consequently there is an option of the external consultant taking a percentage of the income, with an agreement that the arrangement be rolled forward annually for the same percentage of the income achieved from a re-negotiated rate, but otherwise on a no fee basis. Irrespective of the option chosen, there would be a contractual requirement to secure the best terms. In the unlikely event of net costs being incurred, the consultancy fees would be met from the Waste Management Reserve.

# Situation

6. We have secured a contract reducing our gate fees in the last 12 months from £19 to £9 per tonne and now to zero. There is a clear trend showing that the market is changing in our favour and we have recently been advised that White Young Green has had success in negotiating potential contracts with the recycling companies to buy recyclable material resulting in the service being able potentially to secure a substantial income stream. It is an approved supplier under the Office of Government Commerce (OGC) Buying Solutions Technical Assurance Services Framework. The council's requirement falls within the scope of this framework. The current amount of co mingled recyclable material is approximately 8,500 tonnes, and if we secured a contract we would anticipate a contract agreement of between 3 and 5 years.
