POLICY LC1 - LOSS OF SPORTS FIELDS AND RECREATIONAL FACILITIES

- a) Replacement facilities will be provided that better meet local recreational needs;
- b) The need for the facility no longer exists.

Therefore it is suggested that if recreational sites are to be developed in the countryside they should bereplaced by improved facilities, generally within the same settlement.

Sport England would also support the addition of our other exceptions E2, E3, and E5 to this policy although obviously these will not be applicable to allotments and a distinction will need to be made.

Reason(s) for Amendment(s) Sought: Sport England considers that the wording of this policy is imprecise and could be open to misinterpretation. Policy should more closely reflect Sport England's own policy on loss of playing fields.

Comments:

Some amplification of the policy in supporting text would be of value.

Recommendation:

Supporting text to state:

This policy is concerned with total or partial loss of playing fields, open space and allotments. It applies whether the facilities are still in active use or whether through ownership, for example, this is now prevented. It also applies to development that would prejudice the use of land as playing fields, open space or allotments. It is not intended to prevent the provision of facilities such as changing rooms, pavilions and club houses. If replacement facilities are proposed these must be at least as good as those lost in terms of location, quantity, quality, and management arrangements. They must also be made available before development of the existing site begins. An assessment of current and future needs will need to submitted demonstrating that there is an excess of playing fields in a locality and the catchment of the facility, or that the site has no special significance to sport or recreation, if planning permission is to be granted for development under exception b).

POLICY LC2 - RURAL COMMUNITY FACILITIES

Community facilities will be permitted on a site outside settlements if all the following criteria are met:

- a) The need for the facility can be demonstrated;
- b) The need cannot be met on a site within the boundaries;
- c) The site is well related to a settlement.

Land at Sheds Lane identified for sports pitches through SW12 of the Adopted Local Plan should be retained. In addition land adjacent of Herberts Farm is ideally suitable for sports pitches by extending the existing neighbouring playing fields thus creating economies of scale.

It is inappropriate to identify these sites unless there is some certainty of their development as playing fields and there is site-specific policy. It is now understood that the topography of the land as Sheds Lane makes it impractical as playing fields. Should there be a proposal for these or any other sites then they will be considered on their merits in the light of policy LC4.

Hotels are an important facility for airports and eveidence from other airports of a similar scale demonstrates that the number of hotels at Stansted is very low. Hotels in close proximity to the airport serve the needs of passengers who have flightseither leaving early or arriving late in the day, Driving while tired is increasingly seen as dangerous and overnight accommodations close to the airport is essential.

Development outside airport boundaries will be permitted on appropriate sites close to Stansted Airport on junctions with the main road network of if a) it involves the re-use of a rural buildings orb) it is an extension or replacement of existing serviced accommodation.

Reason(s) for Amendment(s) Sought: Encouragement to provide hotel accommodation should not be restricted to sites within Settlement boundaries because this may inhibit such development coming forward. Support should be given

to the construction of new hotels on appropriate greenfieldsites elsewhere within the District such as those close to Stansted Airport and the main road network.

Comments:

Regional Planning Guidance is that the sub region of West Essex remains an area of restraint in terms of future urban development, with the M11 Motorway route being considered as a corridor largely for movement only and not fur urban growth. The vision of the Structure Plan is that new development will be focussed primarily within the built up area of the larger towns and the countryside will be strongly protected from inappropriate development. The District Strategy is to direct development to the main settlements and protect the countryside. It is therefore not appropriate to encourage hotel development close to the airport.
