Key issues in economic development in Uttlesford

Uttlesford is an affluent area with a highly educated population. Unemployment is currently less than 1%.

Currently Uttlesford faces a number of issues which impact on the economy including:

- High levels of out-commuting from the district leading to pressures on the infrastructure
- Some businesses expressing problems expanding within the district
- Equality and diversity issues, e.g. disabled people in rural areas having difficulties accessing jobs
- Many businesses have difficulty recruiting people with certain skills, caused by a number of factors including the high cost of living within the district
- Local people want access to services/businesses in their area but businesses may find it too expensive/ too much hassle to locate here

In addition to the existing problems over the next few years Uttlesford faces a number of issues which will impact on the local economy including:

- 8000 new houses in the district where will people work and will outcommuting lead to dormitory towns?
- Could Uttlesford become over-reliant on airport jobs?

UDC's economic development strategy

Over the next six months the Economic Development Team will be developing an economic development strategy for the council and will work closely with partner organisations with interests in economic development.

The strategy will address:

- What can Uttlesford District Council do to enable economic development within the district – e.g. monitor its own policies and impacts on business
- What can Uttlesford District Council do in partnership with others to encourage economic development in the district. Key partners include:
- Local business sector
- Voluntary sector
- Regional bodies Greater Cambridge Economic Partnership and the Greater Essex Prosperity Forum, etc
- Uttlesford's Local Strategic Partnership (LSP)
- How to attract funding for projects in the district to encourage economic development and work with partners to use this funding
- Dealing with equality and diversity issues within the Uttlesford workforce

The economic development team will also be:

- Developing a tourism action plan to make the most of the opportunities for attracting visitors to the area over the next five years
- Providing research and analysis on economic issues within the district
- Supporting town partnership groups to improve the market towns
- Engaging with the business community on council issues

3 Car Parking Action Plan – update for information

Following lengthy and detailed work by the Decriminalised Parking Enforcement (DPE) Working Group, a report was taken to the meeting of the Environment Committee on 7th November 2006 recommending a number of actions and policies which were all agreed by the Committee.

A position statement on each item (as detailed in appendix C3 of the original report) and forward action plan is presented in the appended table below:

4 Policy on renewable energy

Concern has been expressed over the Council's planning policy to be applied in dealing with a potential planning application for a wind farm at Linton, a small part of which would lie in the north of the district. No comment can be made at this stage as no application has been received.

The relevant policy in the Structure Plan is EG4. This states:

- "Proposals for renewable energy schemes will be permitted provided there is no materially adverse impact upon:-
- 1. Existing land-uses by reason of pollution, odour, noise, or loss of visual amenity;
- 2. The local highway network including the convenience and safety of road users;
- 3. Telecommunications networks, radar installations and flight paths for aircraft;
- 4. Areas of Outstanding Natural Beauty, the Coastal Protection Belt, statutorily protected nature conservation sites, landscape character, historic settlements, or buildings/areas of architectural, historic or archaeological importance.

In relation to off-shore schemes, the visual impact of associated on-shore electricity transmission equipment should be minimized, preferably by the undergrounding of cables, and servicing for the development should be from existing local port facilities."

The principal policy in the local plan is ENV15. This states:

"Forms of renewable energy include wind power, solar power and biomass (plant materials either grown specifically for energy production or generated as a by product of another industry such as forestry wastes). In Uttlesford it is expected that acceptable schemes in the District would be relatively small scale e.g. solar panels, single wind turbines serving single or small groups of dwellings and/or businesses. Schemes should be sited close to settlements or groups of buildings in rural areas and close to the origin of the energy resource. Development will only be permitted in locations where the local road network is capable of handling any additional traffic generated by the proposal.

Policy ENV15 – Renewable Energy

Small scale renewable energy development schemes to meet local needs will be permitted if they do not adversely affect the character of sensitive landscapes, nature conservation interests or residential and recreational amenity."

The East of England Plan will become increasingly relevant as part of the Development Plan. In its present status it sets renewable energy targets and advises that issues of location and scale will require careful consideration, with the Regional Assembly issuing further guidance at some stage in the future

The Government's Energy White Paper, 2003, will be a material planning consideration. The Energy White Paper 'Our energy future – creating a low carbon economy' (2003) sets a domestic goal to reduce carbon dioxide emissions by 60% below current levels by 2050. Other national goals are to maintain the reliability of energy supplies, promote competitive markets in energy and ensure adequate and affordable heating in every home. A doubling of the 2010 renewables' share of electricity is aspired to by 2020. The Government has introduced a number of initiatives including a new 'renewables obligation', to succeed the non-fossil fuel obligation and the climate change levy.

The usual development control policies for development in the countryside will also apply.
