Title: BULKY WASTE CHARGING

Summary

1 Members are offered the opportunity of revisiting the Waste Strategy for Uttlesford 2005 in respect of its policy for the Bulky Waste Service for domestic properties.

Recommendations

- 2 That Members consider the introduction of a charge for bulky waste and select a charging structure from the list of options.
- 3 That members agree the level of charge.
- 4 That a Recycling booklet is produced this year to supersede the May 2006 edition.

Situation

- 7 The number of collections continues to rise as does the cost of providing the service, notably the cost of fuel.
- In accordance with the strategy the council offers a free collection service for items of furniture and white goods. Other items that are part of the fixtures and fittings of a domestic property are chargeable e.g. boilers, kitchen units, bathroom suites. Commercial fitters of such items have a responsibility to deal with waste resulting from their business and need not be funded by the local authority.
- A requirement of the Waste Electrical and Electronic (WEE) Regulations place a responsibility on suppliers to remove and recycle large items such as cookers, fridges and freezers, most do this at low cost (most commonly £7) or free of charge.

Collection arrangements

- There is a requirement to collect fridges and freezers separately from other bulky waste to permit responsible disposal.
- Other bulky waste items are tipped into landfill, there are no opportunities for UDC to separate and recycle. However, householders can pursue reuse by choosing other routes for disposal of items such as donate to charity, sell, and deliver to a Recycling Centre.

Other Authorities

- 12 Table 1 attached to this report show that 19 of the top 21 recycling authorities apply a charge for bulky waste.
- Table 2 shows the arrangements for other Essex Authorities. This evidences that those authorities that do not apply are charge are all at the top of the table for number of collections per household and generally have increasing numbers to deal with. The reverse applies to those that charge with collections per household generally reducing and having a lower number of collections per household.

Targets

14 Anecdotal evidence suggests that customers will be prepared to pay for a service particularly if the service can be prompt or by appointment.

Options

- 15 Charging structure that limits the number of items and a permits low cost or free first collection in each financial year and then applies a charge for all subsequent collections in the same year sufficient to recover their cost.
- 16 Fixed charge for a fixed number of items.
- 17 A separate charge for white goods from other bulky items.
- 18 A fixed charge for a set number of items and charge per each additional item.

Pay-Offs/Penalties

19 This will bring some equity to those residents that rarely use the service in balance with those who access the service frequently.
