## Summary

The Regional Assembly has submitted formally a draft policy to the Secretary of State indicating by district the number of net additional pitches for gypsy and traveller caravans over the period 2006 to 2011. In Uttlesford, the policy proposes a net addition of 15 pitches by 2011, increasing the number of authorised pitches from 37 to 52.

#### Situation

- The Regional Assembly has been working closely with planning authorities to identify the number of additional pitches required to meet the needs of Gypsies and Travellers. The policy is based on a number of research studies, which identify an urgent need for more provision. The draft policy is being proposed as an amendment to the Regional Spatial Strategy. The location and design of pitches within District, Borough or Unitary Authority will be a matter for local development documents.
- The current pattern of provision for Gypsies and travellers is concentrated in particular parts of the region. The proposed distribution of additional pitches follows a similar pattern with the highest number of additional pitches in Fenland (89), South Cambridgeshire (59), Basildon (81) and Kings Lynn and West Norfolk (53). However, all authorities will be required to provide an additional 15 pitches to broaden the choice available to the Gypsy and Traveller community.
- The draft policy represents an equitable approach to this pressing issue.
