Item for decision

Summary

- 1 This report asks Members of the Committee to authorise the transfer of a play area currently in the Council's ownership to Great Dunmow Town Council.

Recommendations

- 2 That the Community and Housing Committee recommend to Finance and Admin Committee the transfer of the Woodlands Park play area to Great Dunmow Town Council at nil value.

Situation

5. As part of the development of Woodlands Park, a piece of land was designated as a play area. Estuary Housing Association, the Housing Association managing the affordable housing were asked to contribute £30,000 for play equipment. This has been provided on the land and the local children living on Woodlands Park are now enjoying the play area. The play area has been transferred into the Council's ownership however we do not have the expertise to manage the area.
6. Officers have been liaising with Great Dunmow Town Council about the future management of the area. The Town Council already inspect the area regularly for the District Council and they have indicated that they are happy to take on the management of this space.
- 7 This report is asking Members to approve to Finance and Admin Committee the transfer of the play area to the Town Council.
