DCL45 HACKNEY CARRIAGE AND PRIVATE HIRE FEES

Members considered the report which advised the Committee of the need to increase the scale fees in respect of drivers' licences, vehicle transfers and vehicle testing to cover the costs incurred and recommended the revised fees be charged from 1 September 2003.

The Head of Environmental Services reported that the licensing function of local authorities required that fees and charges are set to cover the costs associated. Therefore, the Council should not over a period make any surplus through the provision of this service. Members agreed that the increases in fees were justified and necessary to cover the Council's expenses.

RESOLVED that as from 1 September 2003:-

- (i) The hackney carriage and private hire drivers' licence fees be increased to £80 per year and the joint drivers' licence be increased to £100 per year.
- (ii) The vehicle transfer fee be increased to £50.
- (iii) The vehicle inspection fee be increased to £35.
