Communication/Consultation	The original concept of adding to the current location in Saffron Walden was the idea of the Trade Associations. Consultation has been made with the Chief Constable and relevant Town Council.

	to the trade, as although the Council is entitled to recover the cost of issuing and administering licences this is a one off expense so not recoverable. Additional expense would be incurred if a further rank were made available in the High Street in the region of £2000. This would include the amending of the Traffic Order and signage. Funding for this project could be made available by the Highway Authority but would have to be assessed in accordance with their priorities.

## Situation

1 On 31 May 2006 the Assistant Chief Executive gave a verbal report to members following representations made by the Trade Associations to relocate the Taxi Ranks in Stansted and Saffron Walden. Following that report members resolved for officers to consult informally with the respective Town and Parish Councils, the Chief Constable and the Highway Authority.

- 2 The matters relating to Saffron Walden concerned relocating from Market Street to the High Street with three spaces being allocated on either side of the road.
- 3 Following that resolution, the Town Council were consulted and after a due debate they rejected the proposals on the grounds that it would reduce onstreet parking and that they considered that the ranks would not be regularly used.
- 4 The Uttlesford Licensed Operators and Drivers Association who proposed these measures then entered into negotiations with the Saffron Walden Town Centre Management Working Group whereby after due deliberation it was agreed by that Association to reduce the allocations of spaces from 6 to 4 again two being on each side of the road. The location of these stands would be adjacent to both Bus Stops in High Street, Saffron Walden.
- 5 The initial and subsequent correspondence received from the Town Council indicates that they would support a resolution of having one space either side of the highway adjacent to each bus stop.
- 6 The consent of Essex County Council Highways Department must be obtained before any work is commenced however they are unlikely to give that consent unless there is support from the Town Council.
- 7 Consultation with The Chief Constable reveals that the establishing of further ranks in the High Street can help in reducing crime and disorder but they make no comment on the number of vehicles that can ply for hire from that location.
- 8 The Trade Associations seek to retain the site of the rank in Market Street albeit it would be moved closer to the junction with Hill Street thus allowing disabled parking to be used on the current site.
- 9 Consultation with the Trade Associations reveal that they support the proposals for a further taxi rank on either side of the road in High Street, Saffron Walden.
