# **Vehicle Testing**

## Situation

- 4 Uttlesford District Council operates an open and transparent policy when dealing with the Hackney Carriage and Private Hire Trade and is seen by other authorities as operating a system of best practice.
- 5 This policy is reinforced by the holding of three yearly meetings with the trade who meet under the UTDA banner.
- 6 This forum was placed on a formal footing in 1998 by the current licensing officer where officers and trade representatives meet to discuss issues affecting both parties. The forum now includes members of the Licensing Committee.
- 7 Our current practice in respect of vehicles state that vehicle inspections must take place at six monthly intervals or on an annual basis subject to the age of the vehicle. This is determined by the date of first registration contained within the V5 document.
- 8 When a vehicle is due for an inspection a computer generated letter is sent to the proprietor or operator of that vehicle giving the date the inspection is due by.
- 9 Upon a satisfactory inspection being completed the date on the computer is then amended to reflect a further six months or one year depending on the age of the vehicle.
- 10 Currently the VOSA MOT test regulations permit a vehicle to be taken in for a test one month prior to the inspection date. However, if taken advantage of the date of the next inspection will still remain the same albeit it was taken in early.
- 11 Operators are suggesting that we amend our current working practice to reflect that of VOSA.
- 12 The advantage is that operators will have a greater degree of flexibility when booking tests at one of our approved garages, especially those with a large fleet of vehicles.
