Summary

1. This report asks the Committee to set its fees & charges for 2010/11, as set out in Appendix A.

- 2. Where the Council has discretion over its fees & charges, a review has been carried out by officers which takes into account economic conditions, service objectives and expected activity levels.
- 3. With licensing fees there is an objective to ensure that income levels are aligned with the costs of providing the service (including overheads). Following a review of fees this Committee approved a reduction in drivers licence fees at the Extraordinary meeting on 21 December 2009.
- 4. Licensing fees are not subject to VAT so the recent rate change has had no effect.
- 5. Changes in fees & charges are within the context of the Council's Medium Term Financial Strategy and 2010/11 Budget Strategy. Inflation (Consumer Prices Index) is currently (November 2009) 1.9%.
- 6. As detailed in the Members Bulletin issued on 4 December, a new pricing & concessions policy shall be developed and consulted upon during 2010, for implementation in 2011/12.

Recommendations

7. The Committee is recommended to approve the 2010/11 fees & charges as set out in Appendix A.
