**LC74 APOLOGIES FOR ABSENCE AND DECLARATIONS OF INTEREST**

Councillor D J Morson declared an interest in so far as he recognised the driver as someone he knew socially through the church.

The Assistant Chief Executive advised Councillor Morson that he could remain a part of the Panel for the hearing unless he thought a member of the public, knowing the connection between the Councillor Morson and the driver, might think the Councillor's judgement might be affected by that connection, in which case Councillor Morson should withdraw from the meeting. The decision regarding public perception was one to be taken by Councillor Morson alone.

Councillor Morson decided that it would be right to withdraw from the Panel on this occasion.

The Chairman of the Committee welcomed the remaining Members of the Panel.

**LC76 DETERMINATION WHETHER OR NOT TO SUSPEND OR REVOKE A  
PRIVATE HIRE DRIVER'S LICENCE**

The Members of the Panel and officers introduced themselves to the driver and his companion John Street who was a representative of a relevant Union.

The Assistant Chief Executive explained the procedure to be followed at the hearing.

In answer to a question from the Licensing Officer the driver confirmed that he had received the papers for the hearing.

The Committee considered the report presented by the Licensing Officer setting out the circumstances of the case.

In answer to a question the driver agreed that he had failed to notify the Council of a caution within the stipulated seven days. The Union representative said on the driver's behalf that the driver had thought only points penalties needed reporting.

He also submitted a letter relevant to the driver's character.

In answer to a question from a Member the driver confirmed that he was aware of matters which would be disclosed by an enhanced CRB check.

The Licensing Officer, the driver and the driver's companion withdrew from the room and the Panel of Members began to consider their decision at 11.30 am.
