Situation

- 1 Ian Cronshaw of 1 Washington Meads, Maitland Road, Stansted, Essex has made application to this authority for the grant of a Private Hire Operator's Licence. Examination of the application form does disclose that he did hold such a licence previously but this was revoked by the Committee on 20th March 2013 on the grounds that he no longer met the criteria of being fit and proper.
- 2 The circumstances leading up to the revocation of Mr Cronshaw's licence are set out in the report to the Committee on 20th March 2013. Briefly Mr Cronshaw lost his school contracts. He entered into an arrangement with Ardent Parking , an airport parking business which did not hold an operator's licence with a view to operating private hire vehicles on behalf of that firm. However in practice the operation of vehicles was delegated to Ardent Parking and Mr Cronshaw did not have any real degree of control. As a result records of hirings were not kept in accordance with the conditions attached to the licence and on one occasion (while Mr Cronshaw was out of the country) a private hire vehicle registered to Mr Cronshaw was stopped by police being driven by an unlicensed driver.
- 3 Mr Cronshaw appealed against the revocation of his licence but subsequently withdrew the appeal before it was dealt with by the court.
- 4 Ardent Parking has since changed hands. The new proprietor of the firm has been granted an operator's licence and no longer uses the services of Mr Cronshaw.
- 5 Mr Cronshaw does not meet our licensing standards insofar as he had a Private Hire Operator's licence revoked within the previous 3 years.
- 6 Whilst each case will be dealt with on its individual merits, applications for a licence from a person who fails to meet these standards will not normally be granted.

- 7 Prior to the revocation of his operator's licence Mr Cronshaw had held an operator's licence from the Council for 9 years without any issues arising from the operation of his business. During that time he operated almost exclusively as a school contract contractor.
- 8 If this application were successful then he would continue to trade under the name of Stansted Transport Services who are based in Birchanger. My understanding is that he will use the licence solely in connection with tendering for county council school contracts and he is prepared to offer this up as a condition of licence.
- 9 Mr Cronshaw does hold a current Private Hire Driver's Licence which will expire on 30th September 2013.
