Director of Sky Transfers. Dissolved Feb. he was a sole director. Didnt know how long business had been running but thought 8 years. Did other work apart from airport runs and bookings. were taken by internet or telephone. Operating address was in Tolpary. Company became dissolved due to company secretary/bookkeeper cheating from co. Went to Court and Court said co. should be dissolved - this was 01 July 2013 (date of sequestrating). Suspension delayed due to errors made by HMRC due to lack of paperwork. ∴ aware for 18 months that company was to be dissolved. Date Tracy Donovan left was the date she was arrested. CB was not aware until MC arrived at his premises that the company had been dissolved. Confirmed he was aware that transfers had been taking place since the company had been struck off. People may not have been transferred under Sky Transfers depending on whether private hire, bus or shuttle. Confirmed Sky Transfers taking bookings. Agreed with licensing to allow licence to run until it expired. CB provided a list of all bookings (PH) from 01/01/15. Accepts that bookings were being taken after 27/01/15 using the

name of Sky Transfers. Sub-contracts to 24/7 Ltd and occasionally uses Eastern Cabs - he puts the request on an email to local operators and sees who comes back. Has not accepted any bookings since MC's mty with Mrs. Hatchford. Has made 3 out of 6 people redundant and another to be made redundant tomorrow. Has submitted a new app for licence. Been private hire operator since 1970s and held Sky Transfers licence since 2010 with this council. Due to Mrs. Dawson's destruction of docs extended time in co. being dissolved, advised that he had never received notification from Co's Hse reference closure of company - if he had he would have applied for a new licence straight away. Sol. asked for background papers + report for forthcoming committee hearing + she will be attending. Sol. requested she be advised of outcome of mty.
