## **Gypsy and Traveller Land Availability Assessment Call for Sites**

## **Summary of sites**


11 responses were received through the Gypsy and Traveller Land Availability Assessment Call for Sites, 10 of which suggested potential sites. 9 of these are new sites; one suggests an extension to an existing Gypsy and Traveller site, which has subsequently been granted planning permission for two additional Gypsy and Traveller pitches; and one letter requested that Radwinter Mushroom Farm, a site previously suggested for this use, be retracted as the owners wish to pursue the option of residential development on the site.

The table below lists the sites put forward in the consultation period. These sites have not been assessed by officers and are reported here as a factual response of the consultation. The Call for Sites is simply a list of suggestions of sites for Gypsy and Traveller development. Inclusion in the list is not an indication that the site is suitable for development. The Council cannot make any commitment or comment about any land put forward in the study at this stage. The Call for Sites does not preclude landowners and developers submitting planning applications for development.
