#### **Situation**

- 5. The draft local plan was published for consultation in June 2012. Since then the Council has carried out further work to determine the objectively assessed housing need for the district. This work has shown that a plan based on the housing numbers and sites suggested in the draft plan is unlikely to meet the objectively assessed housing need within the district and is therefore unlikely to be found sound at examination. At the working group meeting on the 17<sup>th</sup> October 2013 Members considered a paper on this subject.
- 6. Under the previous item on the agenda Members were asked to identify preferred sites to accommodate the extra housing numbers. While 3 of the additional sites identified Ashdon Road, Saffron Walden, Land west of Great Dunmow and South of Stortford Road and Land north east of Elsenham were identified in the Strategic Housing Land Availability Assessment and therefore subject to the Role of Settlements and Site Allocations consultation in January 2012 the fourth site Helena Romanes school has not been subject to any previous consultation. For consistency there should be an opportunity for people to comment on the assessment of the revised housing number for the district and the sites which could come forward.
- 7. The attached paper will be subject to public consultation, it will be available on the Council's website. Anyone who has previously commented on the local plan and has given their e-mail address will receive an e-mail notification of the new consultation. People who have not given their e-mail address will be sent a letter. The statutory consultees will be consulted and this will include neighbouring local authorities and all parish councils. The consultation, pending any scrutiny process will start on Monday 18th November 2013 and end on Monday 10<sup>th</sup> January 2014. This will be an 8 week consultation to take into account of Christmas falling within the consultation period.
- 8. After the consultation officers will prepare a report of the responses. This will be considered by Members and the necessary changes made to the Draft Local Plan. This will then be subject to further consultation in Spring 2014. The purpose of this consultation will be to identify the issues which an independent Inspector will consider when the plan is examined in the Autumn of 2014. Once the Inspector has submitted their report, providing the plan is found "sound" the Council can adopt the plan. This is likely to be early in 2015. The Local Development Scheme has been updated to reflect the new timetable and is the subject of a separate report on this agenda.
