# Saffron Walden Museum Society

## Report to Museum Management Working Group 15<sup>th</sup> May, 2008

The Management Committee met on 29<sup>th</sup> February, and on 24<sup>th</sup> April, 2008. Saffron Walden Museum Society Limited held its first meeting on 1<sup>st</sup> April, 2008.

#### Museum Society

Richard Wallace, Chairman, has moved to East Sussex and has indicated that it is likely that he will have difficulties in attending future meetings. He intends to resign as a Trustee at the Annual General Meeting of the Museum Society on 8<sup>th</sup> August, 2008.

Vice-Chairman Edwin Planterose has resigned as Vice-Chairman and as a Trustee of the Museum Society after many years' service. Tony Watson has accepted nomination to hold this position until the AGM in August.

#### **Retirement of Education Officer**

The Museum Society has been concerned to show its wholehearted support for the educational role of the museum. Jenny Gibsone, the Education Officer, was due to retire in May. With the UDC embargo on all recruitment, her immediate replacement would not take place. The Management Committee therefore made proposals effective until 31<sup>st</sup> March, 2009 to endeavour to ensure an immediate replacement, subject to an appropriate Memorandum of Understanding being obtained from UDC.

The Museum Society Management Committee has marked the occasion of Jenny Gibsone's retirement with a gift.

#### Saffron Walden Museum Society Limited (MS Ltd)

Saffron Walden Museum Society Limited is now registered with the Registrar of Companies, and has received the Certificate of Incorporation dated 10<sup>th</sup> January, 2008; company number 6469141. The company has also been registered as a charity with the Charity Commission from 14<sup>th</sup> March, 2008; registration number 1123209.

MS Ltd, at its first meeting on 1<sup>st</sup> April, drew up a programme of matters to be dealt with which it advised to the Management Committee meeting on 24<sup>th</sup> April; this will include a re-consideration of the allocation of responsibilities in the re-structured organisation. On the 24<sup>th</sup> April, the Trustees agreed the Resolution to be recommended to the Annual General Meeting of the Museum Society. This provided for the transfer of all of the Museum Society's assets to MS Ltd, and also authorised the officers to sign the appropriate documentation.

The Management Committee has also agreed that the first Annual General Meeting of Saffron Walden Museum Society Limited would be held immediately after the final AGM of the Museum Society on 8<sup>th</sup> August, 2008. Page 1
