Question	Response
CCTV what is their use and do they cut crime – what evidence here?	We don't have many systems in Uttlesford – only in our busiest three spots and obviously more sophisticated ones at the airport. I am convinced that the existence of CCTV has an impact on crime and the fear of crime. It is not always possible to afford staff to constantly monitor CCTV in our towns – after all we get about 7 crimes a day across the whole district and only a small proportion of those are committed within the covered areas. The systems are recording though and that means that if an incident happens we can go back to the system and look at what it shows. Unfortunately, we do not measure the fact that a crime has either been solved by CCTV or has contributed evidence to specific investigations though CCTV but as systems become more sophisticated we are able to get pictures more quickly to the newspapers for appeals and also around to other agencies who may know who offenders are.
Can we have 20 mile an hour speed limits in towns?	No I don't think so. And in any case it is a matter for the Highways agency. We can still deal with careless and any other driving that falls below the standard of a careful and considerate driver so 30 mph might be inappropriate at times. Having the Road Policing Unit based at Dunmow now means they are in Uttlesford towns and villages more and where speeding is on the neighbourhood action panel priority it is genuinely being dealt with. Is there a specific area of concern?
Timing of speed traps near schools to be useful must be at peak times	I have spoken to Bob Beckwith the Road Policing Unit sergeant about this and refer you to my previous answer about the increased activity. I would also like to encourage more parish councils to get involved in Community Speed Watch schemes which are also having a real impact on the speed of vehicles – he also provides some additional information. Regular stop checks and safety events have been carried out/run, whereby we speak to motorcycle riders about safe riding and riding responsibly. These events are called either 'Bike Safe' or 'Pit Stops' which have been held throughout the summer at both Leaden Roding and at Finchingfield, both of which are on the bike circuit. We will be at Finchingfield at the end of this month again with a 'Bike Safe' event.
	We have dealt with speed complaints across the district. This does not include individual daily checks carried out by our officers. Additional speed/traffic enforcement checks have also been funded via the Safety Partnership with Essex County Council, which has resulted in some areas receiving a lot of additional attention. Again, I would prefer specific areas of concern to go to the
	neighbourhood action panel where a plan of action can be drawn up to counter the problem using more available resources than just the police. It is time that communities took their share of the responsibility for solving these problems.

Issue with increased crime in Shire Hill since the streetlights were turned off?	Statistics show that since the street lights were switched off we have not seen a rise in crime. Indeed, in Saffron Walden town it has decreased. However, where number of incidents can be demonstrated it might be possible to make a case to turn street lights back on in those areas.	
	The number of incidents and crimes that occur between midnight and 5 am is very small and I do not believe has been impacted upon by this initiative. I understand that the perception maybe that the light provides safety but only the town centres have this lighting generally – our officers are patrolling all areas in the night paying particular attention to industrial areas. Any areas with CCTV are exempt from the scheme so are areas of specific criminality –we do not have these. Please remember that there was as much, if not more, crime before the part night lighting scheme. It may be that some adjustments need to be made over the time of the pilot.

Where will social housing be built when all brown field sites in Uttlesford are filled?	Redevelopment of existing built up areas is a process that can continue to provide sites for social and mixed tenure developments. Judgements about the potential rate that brownfield opportunities will come forward over the next 15 years indicate, however, that green field sites for thousands of homes will be needed. These will include 40% affordable housing, which includes an element of social housing.	
Where is the evidence that "quality councils" are being given more responsibility through delegation from UDC?	The Local Strategy Partnership (Uttlesford Futures) has in conjunction with its partners prepared a Sustainable Community Strategy. The aim is to draw all agencies and local authorities together to develop initiatives that contribute towards improving the quality of life in Uttlesford.	
Engagement with the voluntary sector organisations within Uttlesford Futures. How will this work?	The Chair of the CVSU is a representative on the Uttlesford Futures Board and on the Management Team. It is anticipated that both the CVSU and District Council officers will liaise with the voluntary organisations to keep them informed about Multi-Agency Community Forum Meetings and the work of Uttlesford Futures.	
Social Services		
What will happen to the residents who currently reside in Stanley Wilson Lodge whilst refurbishment takes place?	There are advocates and Social Workers involved and each resident and relative are involved in a review of need and assistance to source placements. We are, as far as possible, trying to relocate residents in the locality subject to availability of beds, however, some relatives live in Cambridge/Suffolk and are looking in those areas. Paperwork detailing each residents need will be given to the new homes and all residents will be assessed to ensure the correct home is sourced to manage each residents needs. Any transfers are assisted by the home with transport arranged and staff to escort residents and help to settle them in their new home. All residents will also be reviewed by Social Workers after 2 months following relocation.
