Summary

Uttlesford District Council is required to report (by 30th June 2008) its performance for 2007/08 via publication of a Best Value Performance Plan (BVPP). It is the Performance Team's intention to produce a BVPP consisting of a statement certifying compliance with the Code of Practice on Workforce Matters along with performance data for all Best Value Performance Indicators (BVPI's) and Local Performance Indicators for 2007/08 as per Government requirements.

As BVPI's have now been replaced by the new National Indicator Set (with effect from 1 April 2008) this is the last year that best value authorities will be required to compile a BVPP.

Recommendations

That the Performance Select Committee approve the content of the Best Value Performance Plan, including all outturn data and associated narrative, prior to its publication.

Situation

- 1. Uttlesford District Council must publish a Best Value Performance Plan by 30th June 2008, a copy of the outturn data is attached.
- 2. Calculation and data checks have been completed by the Performance Improvement Team on both Best Value and Local Performance Indicators.
- 3. The BVPP itself will not be subject to an external audit by the Audit Commission, however auditors will review some of the reported 2007/08 BVPI data.

Legislative Background

4. A Letter to Chief Executives of Best Value Authorities dated 7 March 2008 sets out the reporting requirements for 2007/08 performance data (via the Best Value Performance Plan (BVPP) 2008). The content of the 2008 BVPP will be restricted to the reporting of outturn performance data together with a statement certifying compliance with the Code of Practice on Workforce Matters.

Production and Circulation

- 5. The BVPP must be published by 30th June. In order to meet this deadline, it will be necessary for the Performance Select Committee to authorise the BVPP and inclusion of any remaining outturn data.
- It is proposed to make the BVPP available on the internet. A minimum number of printed copies of the BVPP will also be made available for receptions and libraries.

Performance Data

- Any remaining gaps in performance data contained within the BVPP will be updated nearer publication date as/when the data becomes available. For several indicators data verification by Essex County Council is still awaited.
