- 6. The purpose of this report is to provide management and members with:
 - Details of the work completed by Internal Audit since the last report to the Members of the Performance and Audit Committee at its meeting 16 August 2012;
 - ii) A summary of the risk level 3 and 4 highest priority recommendations made and agreed;
 - iii) Performance against the Internal Audit Work Programme 2012/13;
 - iv) Details of any risk level 3 and 4 highest priority recommendations not implemented within the agreed timescale;
 - v) Details of any risk level 1 and 2 lower priority recommendations not implemented within the agreed timescale.

Work Undertaken by Internal Audit 04 August to 09 November 2012

- 7. Since the last report to the Committee:
 - i) Between 04 August and 09 November 2012, 11 audits from the 2012/13 audit programme have been completed with 10 Final Reports issued with a total of 30 recommendations made (no Final Report is issued on completion of Annual Governance Statement work). All Final Audit Reports issued have been copied to Performance & Audit Committee members and are available on the Council's Intranet. An overall summary of final reports issued is presented at Appendix A;
 - ii) There are 10 risk level 4 or 3 highest priority recommendations arising from the final reports, details of these are presented at Appendix A;
 - iii) Between 04 August and 09 November 2012, work started on 16 audits from the 2012/13 Audit Programme, of which 2 have been completed and final reports issued and 2 have been completed to draft report stage.

Details of performance against the revised Internal Audit Work Programme 2012/13 is presented at Appendix A.

Audit Work Programme 2012/13 Review & Revision

- 8. The Internal Audit Work Programme 2012/13 presented at Appendix A is a rolling programme of planned audit work subject to regular review and updating at strategic points throughout the year. The first review was undertaken in July 2012. A second review was undertaken in September 2012 to allocate initial time to preliminary key financial work ahead of confirmation from the new External Auditor, Ernst & Young, of work that may be required under any new managed Audit Protocol for 2012/13
- 9. As of 09 November 2012, Internal Audit year to date work against the revised audit programme is:
 - i) 29 out of 39 Audits commenced (74 %)
 - ii) 14 out of 39 Audits completed to draft report stage (36 %)
 - iii) 2 out of 39 Audits completed to Interim report stage (5 %)
 - iv) 12 out of 39 Audits completed and Final Reports Issued (31 %)

Recommendations Implemented 04 August to 09 November 2012

10. There are 4 risk level 3 and 4 highest priority recommendations which have been implemented; a summary is presented at Appendix B.
