**PC77 PLANNING APPLICATIONS**

**(a) Approvals**

**0498/12/FUL Saffron Walden** – variation of condition C.3.1 ( the development hereby permitted shall be implemented in all respects strictly in accordance with the submitted plans contained in the application unless agreed in writing by the local planning authority) of planning application UTT/0522/09/FUL. Revised plans submitted to change plots 4 and 5 from 2 x 2 bedroom units to 2 x 3 bedroom units to match house type on plots 6 and 7 – former gas works, Radwinter Road for Taylor Wimpey East London.

**0370/12/FUL Felsted** – proposed erection of domestic stable – Land at Causeway End, Chelmsford Road for Mr G Moss.

**0352/12/FUL Farnham** – Erection of a new agricultural grain store, farm office and workshop building – Land at Wickham Hall Farm for Mr D Harvey.
