Summary

1. This item seeks the Committee's consideration of proposed felling of 7no. beech trees in the grounds of The Delles, Carmen Street, Great Chesterford. The trees are subject to UDC tree preservation order No. 1/75.

Recommendations

2. Consent is granted for the proposed tree felling subject to conditions:

Prior to any felling of trees on the site a scheme of replacement tree planting to be submitted to the local planning authority for approval in writing. The approved scheme of tree planting shall be fully implemented during the first planting season (Oct -March) following felling.

Reason: The reason for applying this condition is to maintain tree cover in the interests of visual amenity.

Situation

- 4. An application for consent to fell 7no. beech trees situated in the grounds of The Delles has been received (Appendix 1: Plan showing trees proposed to be felled). The reasons given by the applicant for seeking to fell the trees are that they are in poor condition and pose a risk.
- 5. The beech trees have been inspected by the Council's Landscape Officer and were found to be mature specimens in poor general health having a range of significant defects including areas of extensive decay, crown dieback, and branch failure. There is a risk of a major failure occurring to any of these trees if they are retained. There is no remedial surgery which would allow the trees to be satisfactorily retained in the medium or long term.
