Situation

- Local Government Act 2000 Guidance sets out the role of overview and scrutiny committees in fourth option councils (ie those retaining a committee system) as:
 - Reviewing policy and assisting in policy development
 - Scrutinising decisions and decision-making for any council function except regulatory functions such as planning and licensing
 - Investigating other matters of local concern
 - Ensuring councils fulfil their duties relating to Best Value
 - Ensuring procedures are in place for councillors to feed in community views to policy development and decision making
- The Centre for Public Scrutiny (www.cfps.org.uk) cites policy review and development as the most impressive aspect of overview and scrutiny. The key factors in this success are:
 - Selecting significant review topics where scrutiny can add value
 - Rigorous project planning with careful scoping of terms of reference, etc
 - Range of investigative methods adopted, ensuring that a range of experiences and views are represented including focus groups, site visits, mystery shopping, 'select committee' approach, etc
 - Well-presented final reports
 - Follow up of recommendations
- It is also important that Members take the lead in scrutiny, backed by appropriate officer support. It is therefore usual for review reports to be written by the Members undertaking that review, rather than by officers.
- With two broad scrutiny investigations currently underway (fees and charges, and climate change), it would be sensible to identify two or three further topics as early as possible for the 2006-07 year, and to identify areas for scrutiny at regular Review and Petition Committee meetings.
- It is suggested that the Committee may want to look at more *external* scrutiny topics, and the list below therefore includes a wide range of possible subjects, which Committee members may wish to add to before selection.
- In addition, Uttlesford PCT attend two or three meetings a year to discuss their plans, and answer questions from Members.
