 - customer care training a programme of customer care training is being rolled out in association with the customer service centre implementation
 - b) corporate complaints system it is intended that the corporate complaints system will be reviewed with the roll out of the customer relationship management software in the customer service centre.
- The Executive Manager (Strategy & Performance) and the Executive Manager (Finance & Asset Strategy) are currently reviewing processes around value for money, and it is intended to bring to the Committee's November meeting a value for money review process which would involve a review group looking in depth at the costs of services.

Health Scrutiny

- The West Essex PCT will be operational from 1 October 2006. It is intended that the Scrutiny Committee will continue to scrutinise health issues and the new Chief Executive and Chairman of the PCT will be invited to address a future meeting.
- The new Chief Executive is Aidan Thomas. The Chairman is Alan Tobias, OBE. Interviews are still underway for the Director posts once these appointments are made the sub-structure posts will be dealt with. It is hoped that a Director of Public Health will soon be finalised. A Locality Director is expected to be established as the main PCT link within the district. Non-Executive Directors are due to be appointed by the 1 October start date.
