Summary

- **1.** It was agreed at the Full Council on 23 February 2012 that a one off "Jubilee Fund" of £500,000 will be established for 2012/13 to be distributed, as follows
 - a) £250,000 for bids from town and parish councils, and
 - b) £250,000 for bids from voluntary bodies & community groups.
- **2.** Members requested that a scheme for administering the grants be devised and that the community be consulted on the application form criteria, see Appendix 1.
- **3.** Attached at Appendix 2 is a copy of the outcome of the consultation and the proposed changes to the criteria as a result of the comments received.

Recommendations

- 4. That the Scrutiny Committee endorses
 - i) the introduction of the one year only Jubilee Fund 2012/13
 - ii) the Fund should be allocated as follows:

£250,000 for bids from town and parish councils £250,000 for bids from voluntary bodies & community groups

- iii) the criteria for allocation of the funding as at Appendix 1
- iv) the composition of the assessment panel:

Leader and the two Portfolio Holders Finance and Community Partnerships = 3 One independent partner from the Local Strategic Partnership = 1 One from each of the opposition parties = 2

- 1 The introduction of the one year Jubilee Fund will be considered by the Cabinet on the 10 May 2012.
- 2 In establishing this scheme Members particularly specified that they would require the schemes applying for funding to be fully costed, of benefit to the community and awarded grants of a minimum of £1,000 up to a maximum of £10,000. Additionally, for the nine town and parish councils who had New

Homes Bonus money allocated to them in 2011/12 it was decided that no bids could be considered until the 2011/12 funding allocation had been committed.

- 3 The criteria for awarding the funding was established, in accordance with Members' wishes, and this formed part of the consultation document circulated to town and parish councils, voluntary sector organisations and publicised in the local newspapers. The response deadline was 15 April 2012 and 12 responses were received. Attached at Appendix 1 is a copy of the criteria consulted on for both applications from Town and Parish Councils and from Voluntary Bodies & Community Groups. Attached at Appendix 2 is a copy of the comments received and officer responses indicating where amendments to the criteria would be made.
- 4 Members also indicated that they would wish to consider the composition of the assessment panel and the following is proposed (with officer support):

Leader and the two Portfolio Holders Finance and Community Partnerships = 3 One independent partner from the Local Strategic Partnership = 1 One from each of the opposition parties = 2
